



## Beat the Book \$90,000 Kiosk Promotion

September 4, 2025 - January 04, 2026

Official Rules & Regulations

1. **Beat the Book** is a BetMGM Kiosk promotion that begins Thursday, September 4, 2025 and ends Sunday, January 4, 2026.
2. No purchase or play necessary.
3. Entrants must be 21 years of age or older to participate and must have an MGM Rewards card and an acceptable form of photo identification including a driver's license (expired or unexpired), military identification card or government issued ID. If a participant is not a U.S. citizen, an unexpired passport or alien registration card is required. All participants must be an MGM Rewards member. MGM Rewards cards are free of charge and located at the MGM Rewards desk, at the west end of the casino floor.
4. One entry per guest per week. Must swipe MGM Rewards card to enter.
5. If a participant has more than one entry per week, they will be disqualified.
6. If a participant submits entries using an MGM Rewards card other than their own, that participant and the participant whom the MGM Rewards card belongs to will both be eliminated from the promotion and will not be eligible for any prize for the remainder of the promotion.
7. Pick selection opens at 10:00am Central Time on Tuesday and closes at 10:00am Central Time on Sunday of each week.
8. Prizes will be awarded on the following Tuesday by 11:00am Central Time.
9. Beau Rivage Management reserves the right to modify available selections at any time.
10. Beau Rivage's "Book Selections" will be made available to the public no later than Tuesday at 10am Central Time on select BetMGM sports betting kiosks.
11. A participant will select the outright winners for each pro football game scheduled for that particular week to be played on Sunday. Monday and Thursday games will not be included in the contest.
12. Each game must be official in order to qualify as a winner. Games are official after 55 minutes of play.
13. Any canceled or postponed games are considered a win for both teams. Any game not played on the original date but rescheduled for a future date, for the purpose of this contest, is considered "postponed".
14. A tie will be considered a win for both teams.
15. A Participant who has a better weekly record than Beau Rivage's "Book Selections," will be considered a winner. A participant who has the same weekly record as the Beau Rivage's "Book Selections," will not be considered a winner and will not be eligible for the weekly prize.
16. Beau Rivage is not responsible for incorrectly entered or missed selections. It is the responsibility of the participant to ensure their picks are entered correctly.
17. Once the participant submits their picks at the kiosk, their selections are considered final and cannot be changed.

Amounts of \$500 or less will be posted directly to a player's account. *FREEPLAY* prizes of \$501 or more will be issued on a temporary MGM Rewards card with prize amount posted to it and must be signed for by the winner. Temporary MGM Rewards cards may be signed for and picked up from the BetMGM Sportsbook during normal hours of operation.

**Each Week:**
