\$30,000 Beat the Hosts Tournament Slot Tournament Promotion Monday, June 30, 2025 June 2025

1. Empire City Casino by MGM Resorts will host the \$30,000 Beat the Hosts Tournament, Monday, June 30, 2025. Tournaments will take place between 3 PM and 8 PM.

2. Drawing Date: June 30th.

ENTRANTS

3. MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS.

4. Participants may receive information about this promotion in several ways including, but not limited to their monthly mailer and traditional advertising methods.

5. This event is open to all hosted MGM Rewards members. Player's hosted status must be valid at the time of the event. Players will be assigned to a "Host Team" determined by who their assigned marketing authorizer (Host) is, as represented in the Patron Management system.

ENTRY PERIOD

6. On Monday, June 30, 2025, hosted MGM Rewards members can visit the Entertainment Lounge to play a session for the \$30,000 Beat the Hosts Tournament.

7. Tournament sessions open at 3:00 PM for hosted MGM Rewards members. Participants must appear at the Entertainment Lounge and play a session during the open session time frame between 3 PM and 8 PM. Following the close of open sessions at 8 PM, prizes will be awarded at 8:30 PM.

8. Session times will occur upon request between 3:00 PM and 8:00 PM.

GENERAL TOURNAMENT CONDUCT

9. Machine seating will be assigned randomly prior to the start of each session.

10. Participants are responsible for appearing at the tournament location to participate within the scheduled open session time frame. Any participant not appearing within the specific time frame will forfeit participation.

11. Players may only participate in one completed, non-malfunction session on the promotional date.

12. In the event of a machine malfunction not caused by the participant during the tournament, entrants may be allowed to record a session score by participating in a different session. If a patron participates in a second session due to a machine malfunction, only the recorded score from the second session will count.
a. Marketing management has sole discretion in determining if a machine malfunction was caused by the participant.

PRIZES

13. Session participants will not be awarded a Session Prize. Prizes will be awarded at 8:30 PM for the Top 20 individual scores from each Host Team.

14. Winners will be awarded *FREEPLAY*® prizes at the tournament location and at the MGM Rewards desk. Winners must be present to claim prize.

17. Once winners' names are verified, the names will be announced via public address system on the gaming floor, displayed at the drawing location, and on the media pods located throughout the gaming floor, as technology is available.

18. A special events representative will be available at the Entertainment Lounge for up to 10 minutes after names are announced to award prizes. Once the 10-minute time frame elapses, winners will have 72 hours to claim their prize at the MGM Rewards desk. If participants do not redeem their prize within the allotted time frame, the prize will be forfeited. No alternates will be called.
a. Cash Method B: Cash winners will be escorted to the cage for payment.
