\$630,000 Thrills and Chills Drawings Virtual Drawing Promotion Saturdays in October October 2025

1. Empire City Casino by MGM Resorts will host the \$630,000 Thrills and Chills Drawings every Saturday in October 2025. Drawings will take place each hour from 6pm until 10pm.

2. Drawing Dates: October 4th, 11th, 18th, and 25th.

ENTRANTS

3. MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS. NO PURCHASE NECESSARY.

ENTRY PERIOD

5. Entry into the promotion is active from September 27, 2025 at 9:45:00pm until October 25, 2025 at 9:44:59 PM.

6. MGM Rewards Members will receive one FREE entry by visiting any Rewards Kiosk, good for one redemption during the promotion period.

7. MGM Rewards Member will receive an additional entry for every \$.25 SLOT DOLLARS® earned on any slot machine or electronic table games during the entry period.

8. MGM Rewards Members are responsible for activating their entries by registering any carded rating within two (2) hours of each drawing time on the drawing date.

GENERAL DRAWING CONDUCT

9. At each hourly drawing, winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracing station.

10. Winning names will be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.

11. Participants may not win more than once per drawing session. In the event of a duplicate winner, an alternate will be drawn until a total of 20 unique winners are drawn for 6pm-10pm drawings.

12. Once winners' names are verified, the names will be announced via public address system on the gaming floor, displayed at the drawing location, and on the media pods located throughout the gaming floor, as technology is available.
