#### **KIOSK GAME CONDUCT**

- 6. Qualified MGM Rewards members may visit a Promotional Kiosk to play the BetMGM Big Game Bets Kiosk Game. Members will be required to enter pin number to access promotional awards.
- 7. All awarded prizes will be BetMGM Online Bonus Bets. BetMGM Big Game Online Bonus can only be used at BetMGM.com. Prize amounts awarded vary by rated play.
- 8. Available prizes vary by criteria. Prize options are as follows:
- a. \$30 BetMGM Online Bonus bet for the first 500 qualified MGM Rewards Members.
- b. \$100 BetMGM Online Bonus bet for the first 700 qualified MGM Rewards Members.
