1. Empire City Casino by MGM Resorts will host the Double Rush Tournaments Drawings every Friday and Saturday in September 2026. Drawings will take place each hour from 6pm until 10pm.

2. Drawing Dates: September 4th, 5th, 11th, 12th, 18th, 19th, 25th, and 26th.

ENTRANTS

3. MUST BE AN MGM REWARDS MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS. NO PURCHASE NECESSARY.

ENTRY PERIOD

5. Entry into the promotion is active from August 29, 2026 at 10:00:00pm until September 26, 2026 at 9:45:00 PM.

6. MGM Rewards Members will receive one FREE entry by visiting any Rewards Kiosk, good for one redemption during the promotion period.

7. MGM Rewards Members may triple entries earned each Tuesday in September.

8. MGM Rewards Members will receive additional entries for every \$.25 SLOT DOLLARS earned on any slot machine or electronic table games during the entry period.

9. MGM Rewards Members are responsible for activating their entries by registering any carded rating within two (2) hours of each drawing time on the drawing date.

GENERAL DRAWING CONDUCT

10. At each hourly drawing, winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracking station.
11. Winning names may be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.
