



Fifty-Fifty Promotion

November 18th 2024 – December 9th 2024

1. You must be at least 21 years of age to participate.
2. The Promotional fund is the amount taken from every eligible poker game pot to fund Poker Room Promotions. A maximum of \$2 will be taken from every pot with \$1 taken on the flop and \$1 taken on a \$20 pot size.
3. The Promotional fund taken from each game pot will be placed in a drop box. The Promotional funds will be collected in a manner consistent with the internal control procedures of the MGM Grand Poker Room.
4. A promotional fund will be added to the Promotional reserve account and fund all present and future promotions.
5. An Eligible Player is any player who is actively playing on an Eligible Game.
 - a. Players that sit out of a hand will be placed in lobby immediately prior to the start of the next hand. EX/ When a player leaves their chair, the player will be placed in lobby exactly before the dealer begins a new shuffle. Guests are returned from lobby when they accept a hand when returning to the table.
6. Eligible Games include any poker game for which a Promotional Fund contribution is collected for purposes of funding the Promotional Reserve Account.
 - a. Promotional Funds will be maximum \$2 drawn from the pot of each game, consisting of:
 - i. \$1 taken on the flop; and
 - ii. \$1 taken on a pot of at least \$20.
 - b. Eligible Games do not include cash games with no promotional draw nor games played as part of a Daily Tournament.
7. **During the promotional period, fifty (50) seats will be awarded to the MGM Grand \$400 No Limit Hold ‘em Tournament. The 50 players with the highest hours played in eligible games will be awarded one (1) entry into the MGM Grand \$400 No Limit Hold ‘em Tournament, which will carry a \$50,000 guaranteed prize pool. Read the tournament structure sheet for complete details.**
8. **The period of measurement will begin Monday, 11.18.24 @ 7:00am and end Monday, 12.9.24 @ 7:00am.**
9. There is no minimum pot size to qualify for this promotion. Players that miss a hand will be immediately placed in lobby. Any discrepancies in hours played must be brought to the attention of the shift manager before the session ends. There is no guarantee that hours will be retroactively added to a player’s time.
10. Entries to the \$400 No Limit Hold ‘em \$50,000 guaranteed event won during the promotional period will be non-refundable and non-transferrable. Players that win entry will be subject to all rules and regulations set forth in the tournament rules. Players will be permitted to register for the \$400 No Limit Hold ‘em tournament only. If a player that has won entry fails to sign up during the registration period, the entry will become null and void. Please read the tournament rules for the \$400 No Limit Hold ‘em event for full details.
11. Poker Room employees are eligible to participate, off shift only.
12. Reduced rake games are eligible for promotions if a promotional fund is being taken and all other requirements are met.
13. Players have the option to not put promotional winnings on the table but can add any amount of the promotional winnings to their stack at the time of the receipt of chips. Chips not in play must be removed from the table. Chips are not in play until received from the MGM Grand Poker Room staff.
14. IRS regulations require U.S. citizens to present valid identification and a social security number.
15. For U.S. Citizens, Form 1099-MISC will be issued for all promotional winnings of \$600 or more. Non-resident aliens without a tax treaty are subject to 30% withholding on 100% of all promotional winnings of \$600 or more and will be issued a 1042-S. The decisions of MGM Grand management regarding all aspects of this promotion are final and binding, subject to NRS 463.362 which governs this promotion.
