2. SLOT DOLLARS® must be earned on the promotional date.
3. MGM Rewards Members can earn Rewards SLOT DOLLARS® by inserting their MGM Rewards Card into any functioning video gaming machine and registering play.
4. Guests may visit a Promotional Kiosk to play the Lucky Loot Kiosk Game. Members will be required to enter pin number to access promotional awards.
