



# OFFICIAL RULES

### June 2026

1. Empire City Casino by MGM Resorts will host the \$250,000 Wild Card Draw card match promotion Fridays in June. Card draws will take place at 5:00 PM, 6:00 PM, 7:00 PM and 8:00 PM.

2. Drawing Dates: Fridays: June 5th, 12th, 19th, and 26th.

#### ENTRANTS

3. Empire City Casino will host card draws for eligible MGM Rewards members Fridays in June 2026.

4. Participants may receive information about this promotion in several ways including but not limited to their monthly mailer and traditional advertising methods.

5. **MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE.** MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS.

#### ENTRY PERIOD

6. Each promotional date, Empire City Casino will host card draws for eligible MGM Rewards Members at 5:00 PM, 6:00 PM, 7:00 PM and 8:00 PM.

7. Invited MGM Rewards Members will receive a combination of a number, color and suit for the month included in their June 2026 marketing mailer.

8. Invited MGM Rewards Members must be present to participate and win. Player's tier must be valid at the time of the event.

#### GENERAL NUMBERS DRAW CONDUCT

9. On each promotional date at each drawing time, 5:00 PM, 6:00 PM, 7:00 PM and 8:00 PM, a winning card will be drawn from a deck of cards.

10. Winning card will be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.

11. Running the Wild Card Game:

- Each drawing time, a new deck of cards will be opened and shuffled faced down using an electronic shuffle machine. Deck will be shuffled 3 times.
- Joker cards and any prior winning cards from that promotion day will be removed prior to shuffling.
- Winning card will be announced via public address system on the gaming floor, displayed at the drawing location, and on the media pods located throughout the gaming floor, as technology is available.
- Top card from the shuffled deck will be the winning card.
- Prizes awarded per hour will be based on the highest match achieved:

12. If a guest matches more than one category in the same drawing, only the highest applicable prize will be awarded.

13. To win a prize, MGM Rewards members must match the color, suit, value, or have an exact match from the set issued to them. Guests may win based on their match each drawing hour.

14. Winners may claim their *FREEPLAY*® at any Promotional kiosk. Guests have until the end of the gaming day to claim their prizes at the promotional kiosk.

Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion.
