



MGM Gold Pyramid of Gold

1. You must be at least 21 years of age to participate. The Promotional funds from every game will be a max of \$3 with \$1 being taken on the flop, \$20 pot size and \$30 pot size. The Promotion rake taken from each game pot will be placed in a drop box on the opposite side of the table from the House rake. The Promotion rake Drop box will be collected and counted in a manner consistent with the internal control procedures of the MGM Gold Poker Room. One hundred percent (100%) of the daily Promotion rake will be posted to the Promotion reserve account daily. The Promotion reserve account will be used to fund the High Hand payouts and other promotions.
2. Only Texas Hold'em cash games are eligible for payouts. Cash games that do not add to the Promotion rake and all Daily Tournaments are excluded from live action promotions.
3. The qualifying hand must be the player's best five card hand after all action is complete. Ex/ The eligible hand is nines full of Jacks. If a player has 999JJ on the turn, only to make Four of a Kind 9's on the river, the hand will not be eligible, as quads is now the new best five card hand.
- 4. Pyramid of Gold is active 24/7.**
5. Qualifying hands are not required to go to showdown but must be a live hand when all action is complete. Players may not fold a qualifying hand and be eligible for a payout.
6. A pocket pair is not required for full houses, however players must use both of their hole cards. Both hole cards must play for all other qualifying hands. A pocket pair is required for quads. Hands that "tie" the board will qualify. Ex/ The pyramid payout hand is 77744. The board reads 77449. The hole cards of 7-4 will qualify.
7. The qualifying pyramid hands will be comprised of Full Houses, Quads and Straight Flushes. The pyramid qualifying hands will be placed at random by poker management before the event begins. Duplicates are permitted.
8. Eligible payouts will start at Tier 1 (\$) of the Pyramid and only Tier 1 (\$) payouts are eligible. When all Tier 1 payouts have been won, Tier 2 (\$\$) of the Pyramid will "unlock" and only Tier 2 (\$\$) payouts are eligible, and so on until the GRAND is reached. This process will continue across all Tiers until all prizes have been awarded.
9. If multiple players make the same qualifying hand, the prize will be split between the eligible players.

10. Payouts and qualifying hands will be posted on the "Pyramid of Gold" board in the poker room.

11. The qualifying hands of the Pyramid of Gold will be built at random by poker management before the event begins.
12. Any discrepancies in the normal process of a hand including any discussion of possible High Hands, pot size, or solicitation to call a bet during the play of the hands, in the discretion of Management, may void the High Hand eligibility for that hand. Any player determined to be manipulating the high hand of the hour result may have their win voided or be removed from the poker room.
13. Poker Room employees are eligible to participate, on or off shift. Reduced rake games are eligible for promotions if a promotion rake is being taken and all other requirements are met.
14. Bomb pots will be eligible for promotional wins, only on the top board. The fundamental rules of the game cannot be altered for a bomb pot to be eligible for promotions. Ex/ If players agree to a PLO Bomb Pot in a NLH game, the bomb pot will not be eligible for any current live action promotions.
15. "Running it Twice" remain eligible for promotional wins on the top board only.
16. Players have the option to not put promotional winnings on the table but can add any amount of the promotional winnings to their stack at the time of the receipt of chips. Chips not in play must be removed from the table. Chips are not in play until received from the MGM Gold Poker Room staff.
17. IRS regulations require U.S. citizens to present valid identification and a social security number.
18. For U.S. Citizens, a 1099-MISC will be issued for all promotional winnings of \$600 or more and tournament winnings over \$5,000 will also have 24% withholding applied. Non-resident aliens without a tax treaty are subject to 30% withholding on 100% of all promotional winnings of \$600 or more and will be issued a 1042-S. The decisions of MGM Gold management regarding all aspects of this promotion are final and binding, subject to NRS 463.362 which governs this promotion. The MGM Gold reserves the right to modify or discontinue this promotion at any time.
