1. It is understood that Northfield Park may or may not assign stall space or other accommodations... 2. Approved trailers will be assessed a \$110 per month rental fee... 3. A \$50 deposit will be required on each stall allocated... 4. Approved stall rent changes will be billed every month... 5. Applicant acknowledges that he/she understands and is subject to the following provisions... 6. Hauling, extension cords, propane tanks & smoking are not permitted... 7. Smoking and grill cooking are only permitted if conducted at least 10 feet away from the barns... 8. Parking of vans, trailers, cars and other vehicles is restricted to designated parking areas... 9. Northfield Park reserves the right to change, add or alter any rules as it deems necessary... 10. Northfield Park reserves the right to change, add or alter any rules as it deems necessary... 11. This license agreement shall not be binding upon Northfield until signed by the racing secretary... 12. Approved trailers shall not remove racehorses from Northfield's premises... 13. Applicant represents that he/she and all persons for whom he/she is acting have read and are familiar with the Rules of Racing... 14. Approved trailers agree to produce a signed training authorization... 15. All owners, trainers, drivers and/or agents and employees must obtain a license as required by the Ohio State Racing Commission... 16. Each horse of different lineage are required in all overnight events... 17. Northfield reserves the right to reject any entry and to decline or revoke stall space to any individual... 18. All other changes for horses stabled on the grounds must be reported to the racing secretary immediately... 19. Northfield may refuse admittance to, exclude or eject anyone considered unwelcome or undesirable... 20. IT IS CLEARLY UNDERSTOOD AND AGREED that this stall allocation is not a lease of space... 21. Stall space is at a premium and applicant agrees that any space not used by him/her in his/her allocation shall unconditionally revert to Northfield at any of the foregoing... 22. In consideration of the license of stall space of the license agreement and other good and valuable consideration connected therewith, the undersigned agrees as follows: a. APPLICANT HEREBY RELEASES AND DISCHARGES Northfield and its employees, officers, agents and assigns, from any and all liability to applicant, its employees, representatives, agents, heirs and assigns, the negligence of Northfield or any of its agents, or otherwise... 23. Applicant grants to Northfield the right to transcribe and reproduce races in which applicant or its agents or employees may participate and agrees that Northfield may exhibit, such transcripts or recordings for any non-wagering purpose without compensation to applicant... 24. Trainer must provide proof of registration with the Ohio Bureau of Workers' Compensation, and also, if from outside of Ohio, proof of workers' compensation insurance from the Trainer's home state... 25. THE UNDERSIGNED TRAINER HEREBY CERTIFIES THAT HE/SHE HAS READ AND UNDERSTANDS AND AGREES TO THE FOREGOING TERMS AND CONDITIONS INCLUDING ALL THE RELEASE PROVISIONS... STATEMENTS OR INDUCEMENTS APART FROM THIS AGREEMENT HAVE BEEN MADE.
