



# OFFICIAL RULES

## \$1.4M Winning Wonderland Drawings Virtual Drawing Promotion Saturdays in November and December November – December 2024

6. MGM Rewards Members will receive one FREE entry by visiting any Rewards Kiosk, good for one redemption during the promotion period.

7. MGM Rewards Member will receive an additional entry for every \$.50 SLOT DOLLARS® earned on any slot machine or electronic table games during the entry period.

8. MGM Rewards Members are responsible for activating their entries by registering any carded rating within two (2) hours of each drawing time on the drawing date.

### GENERAL DRAWING CONDUCT

9. At each hourly drawing, winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracing station.

10. Winning names will be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.
