

# **OFFICIAL RULES**

# \$1.4M Winning Wonderland Drawings Virtual Drawing Promotion Saturdays in November and December November – December 2024

- 7. MGM Rewards Member will receive an additional entry for every \$.50 SLOT DOLLARS® earned on any slot machine or electronic table games during the entry period.
- 8. MGM Rewards Members are responsible for activating their entries by registering any carded rating within two (2) hours of each drawing time on the drawing date.

# **GENERAL DRAWING CONDUCT**
