\$200,000 Double Spins Drawings **Virtual Drawings** Thursdays and Fridays in June June 2025

- 1. Empire City Casino by MGM Resorts will host the \$200,000 Double Spins Drawings on Thursdays and Fridays in June. Drawings will take place from 5:00 PM through 9:00 PM.

ENTRANTS

ENTRY PERIOD

GENERAL DRAWING CONDUCT

- 14. Once winners' names are verified, the names will be announced via public address system on the gaming floor, displayed at the drawing location, and on the media pods located throughout the gaming floor, as technology is available.
