



Casino Video/Photo Requirements & Restrictions: General

As of 11/20/2024

All persons taking photographs and videos within MGM Resorts' gaming establishments (the "Premises") and distributing that content (including in real or in near real-time via social media) must follow the Casino Video/Photo Requirements & Restrictions set forth below and any additional instructions provided by MGM Resorts International or any of its properties (collectively, "MGM") employees. Failure to follow the Casino Video/Photo Requirements & Restrictions or employee instructions may result in, among other things, removal from the Premises. 1. General Rules of the Road

- a. It is your responsibility to comply with all applicable laws, rules and regulations including, without limitation, laws and regulations concerning libel, copyright, pornography, and advertising. It is your responsibility to include any appropriate disclosures required by the Federal Trade Commission ("FTC") and other government authorities, and you are responsible for compliance with the FTC's requirements (and others) including those related to endorsements (as applicable). - b. Do not make false, deceptive or misleading claims about any products or services.
- c. Use only original material created by you or used with written permission of the creator.
- d. Do not disparage, libel, slander, or defame any individual or entity.
- e. Do not post confidential information about any individual or entity, and do not disseminate private facts about another person or otherwise invade their privacy.
- f. The intentional recording of other guests, MGM employees, representatives, agents or consultants without their written consent, even when there is no intent to bother, vex, or annoy, is always prohibited. If any individuals are shown in your content, you must get signed releases from them if required by law.
- g. Do not use the trademarks or logos of any third parties unless you have obtained all of the necessary clearances from the owners. Do not use music unless you have obtained all of the necessary clearances from the owners of the sound recording and musical compositions.
- h. Do not make hateful or offensive comments or make comments that promote racism, bigotry, hatred or physical harm against any individual or group.
- i. Do not communicate any sexually explicit material or any material that contains nudity or excessive violence.
- j. Do not communicate anything about illegal drugs, tobacco, or guns, or other weapons or any unsafe activities.

- k. Follow the posting policy and terms of use of any site on which your communications or content is posted.
- l. Do not link to any content that violates any of these Casino Video/Photo Requirements & Restrictions.
- m. Do not impersonate any other person or entity, actual or fictitious, including any MGM employees, representatives, agents or consultants.
- n. Exercise discretion and sound judgment to prevent incidents which might reflect on the reputation of the State of Nevada and/or the gaming industry.
- o. Do not include in the content anyone who is impaired by alcohol or drugs, whether actual or implied.
- p. Ensure the content is in accordance with decency, dignity, good taste, honesty and inoffensiveness.
- q. Do not make false statements about the gaming industry or game play. For information related to the game mechanics and responsible gaming, please refer to the GameSense literature available at the gaming establishments and online.
- r. Do not engage or encourage behaviors associated with problem gaming.
- s. For table games and dealer-assisted table games, the person playing the table game must be screened off from all real-time communications with others. Delayed communications to and from the person playing the table game are permissible so long as the delay is at least thirty (30) minutes.
- t. Do not possess, permit, or reference cheating, devices used to cheat, or call into question the integrity of any gambling game.

Other Important Considerations:

MGM reserves the right to review any material created by you and in the event any material does not comply with these Casino Video/Photo Requirements & Restrictions or is objectionable based on MGM's reasonable determination, you must remove such material immediately and must not post such material at any time.

MGM reserves the right to remove an individual from the Premises and/or stop an individual from taking photographs, filming videos, capturing content and/or streaming at any time and for any reason.
