- 1. Empire City Casino by MGM Resorts will host the Holiday Cruising Drawings on Friday, July 4, 2025. Drawings will take place from 5pm through 7pm.

ENTRANTS

ENTRY PERIOD

- 7. MGM Rewards Members are responsible for activating their entries by registering any carded rating within one (1) hour of each drawing time on the drawing date.
- 8. MGM Rewards Member will receive an additional entry for every \$1 Slot Dollar earned on any slot machine or electronic table games during the entry period.
- 9. Qualified MGM Rewards Member can visit any MGM rewards kiosk to receive 10 FREE Bonus entries.

GENERAL DRAWING CONDUCT

PROMOTION TERMS AND CONDITIONS
