

Beau Rivage Shrek Scavenger Hunt

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.
MUST BE TWENTY-ONE (21) YEARS OF AGE OR OLDER TO PARTICIPATE.

The Beau Rivage Shrek Scavenger Hunt (“Promotion”) is sponsored by Beau Rivage Resort & Casino (“Sponsor”). By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects.

Sponsor reserves the right to amend, suspend, or terminate the Promotion at any time without prior notice.

1. ELIGIBILITY

The Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia who are twenty-one (21) years of age or older at the time of participation.

Sponsor's computer systems and servers shall serve as the official time-keeping device for the Promotion.

4. HOW TO PARTICIPATE

During the Promotion Period, Sponsor will place seven (7) Shrek character cutouts throughout Beau Rivage Resort & Casino property. Each character cutout will contain a QR code ("QR Code").

To participate, entrants must:

1. Locate a Shrek character cutout on property;
2. Scan the associated QR Code using a mobile device capable of internet access;
3. Complete and submit the online entry form linked through the QR Code landing page.

Multiple participants may enter using the same QR Code location.

Sponsor reserves the right to add, remove, relocate, or modify character locations or QR Codes at any time.

No purchase, payment, or MGM Rewards membership is required to participate or win.

Standard mobile carrier data and usage rates may apply. Entrants are solely responsible for any charges incurred through participation.

Incomplete, fraudulent, illegible, inaccurate, automated, or mechanically reproduced entries may be disqualified in Sponsor's sole discretion.

5. ENTRY LIMITATIONS

Limit one (1) entry per person.

Sponsor reserves the right to disqualify any entrant suspected of:

- using multiple identities;
- submitting fraudulent entries;
- tampering with the entry process;
- using automated systems or bots;
- acting in violation of these Official Rules; or
- engaging in disruptive or unsportsmanlike conduct.

Any attempt to deliberately damage the Promotion or undermine its legitimate operation may be a violation of criminal and civil laws. Sponsor reserves the right to seek damages and remedies to the fullest extent permitted by law.

6. WINNER SELECTION AND NOTIFICATION

Potential winners may be selected in a random drawing from among all eligible entries received during the Promotion Period.

The number of winners, prizes, prize values, and approximate retail values (“ARV”) shall be determined solely by Sponsor and announced separately.

Potential winners may be contacted using the contact information submitted at the time of entry. Sponsor is not responsible for failed, delayed, or misdirected communications.

Potential winners may be required to:

- verify eligibility;
- provide valid government-issued identification;
- sign and return affidavits, liability releases, publicity releases, or tax documentation; and/or
- comply with additional verification procedures determined by Sponsor.

If a potential winner:

- cannot be contacted;
- fails to respond within the designated timeframe;
- fails to provide requested documentation;
- is deemed ineligible; or
- otherwise fails to comply with these Official Rules,

Sponsor reserves the right to disqualify such entrant and select an alternate winner.

7. PRIZES

Prize details, quantities, values, and redemption requirements will be determined solely by Sponsor.

Winners are solely responsible for all applicable taxes, gratuities, fees, transportation, and any expenses associated with prize acceptance or use.

8. PUBLICITY RELEASE

By participating in the Promotion, each entrant grants Sponsor and its designees the unrestricted right to use entrant's:

- name;
- likeness;
- image;
- voice;
- submitted photos;
- video content;
- biographical information; and/or
- entry materials

for advertising, marketing, promotional, public relations, social media, digital signage, theatre screens, website content, or other commercial purposes in any media now known or later developed, worldwide and in perpetuity, without additional compensation, notice, or approval, unless prohibited by law.

Entrants acknowledge that photos or videos submitted or captured in connection with the Promotion may be displayed publicly throughout Beau Rivage Resort & Casino property, social media channels, theatre displays and digital screens.

9. RELEASE OF LIABILITY

By participating, entrants agree to release, discharge, indemnify, and hold harmless Sponsor, MGM Resorts International, and each of their respective parent companies, subsidiaries, affiliates, officers, directors, employees, contractors, agencies, representatives, successors, and assigns (collectively, the “Released Parties”) from and against any and all claims, damages, liabilities, losses, costs, or expenses arising out of or related to:

- participation in the Promotion;
- acceptance, use, or misuse of any prize;
- technical failures;
- lost or delayed entries;
- mobile device issues;
- internet or connectivity interruptions;
- personal injury;
- property damage; or
- publicity rights.

Released Parties are not responsible for:

- interrupted or unavailable networks;
- server failures;
- technical malfunctions;
- unauthorized human intervention;
- corrupted data transmissions;
- inaccessible QR Codes;
- printing errors;
- or any other errors related to administration of the Promotion.

10. GENERAL CONDITIONS

Sponsor reserves the right to cancel, modify, suspend, or terminate the Promotion if fraud, technical failures, unauthorized intervention, Force Majeure events, or any other causes impair the integrity or proper functioning of the Promotion.

“Force Majeure” events include but are not limited to:

- acts of God;
- severe weather;
- pandemics;
- public health emergencies;
- labor disputes;
- government actions;

- terrorism;
- utility failures; or
- other events beyond Sponsor's reasonable control.

Sponsor reserves the right to disqualify any individual who tampers with or attempts to tamper with the entry process or operation of the Promotion.

11. PRIVACY

Information collected from entrants is subject to Sponsor's privacy policies and may be used for:

- administration of the Promotion;
- winner verification;
- marketing communications;
- promotional purposes; and
- other lawful business purposes.

By participating, entrants consent to the collection and use of their information in accordance with applicable laws and Sponsor's privacy practices.

12. GOVERNING LAW

All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules shall be governed by the laws of the State of Mississippi, without regard to conflict of law principles.

Any disputes arising from the Promotion shall be resolved exclusively in the appropriate state or federal courts located in Mississippi.

13. WINNERS LIST

To request a winners list, entrants may submit a written request to Sponsor following the conclusion of the Promotion Period. Sponsor reserves the right to limit or deny requests where permitted by law.

14. SPONSOR RESERVATION OF RIGHTS

Sponsor reserves the right, in its sole discretion, to:

- amend these Official Rules;
- alter Promotion mechanics;
- substitute prizes;
- modify character locations;
- extend or shorten the Promotion Period; and/or
- cancel the Promotion at any time.

Participation in the Promotion constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion.
