## OFFICIAL RULES SLOT DOLLAR® Multiplier Kiosk Promotion Tuesdays June 2026

### KIOSK GAME CONDUCT

6. On promotion dates, MGM Rewards Members may visit a MGM Rewards kiosk to activate the 2x SLOT DOLLAR® Multiplier for each date.
7. Bonus SLOT DOLLARS® are based on SLOT DOLLARS® earned on the promotional date. Offers and bonuses will not carry over to additional dates.
8. MGM Rewards Members can earn SLOT DOLLARS® by inserting their MGM Rewards Card into any functioning video gaming machine and registering play, and by registering any purchases on their MGM Rewards Card.
9. Bonus SLOT DOLLARS® will appear on player account within 30 days of the promotional date.
10. Eligible MGM Rewards Members must be present to participate.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or

employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
