ENTRANTS

6. All MGM Rewards Members can earn \$10 SLOT DOLLARS® playing on any machine to receive a choice of \$30 Shopping Dollars or \$30 *FREEPLAY*®, up to 5X.
7. Upon selecting the Shopping Dollars option at any promotional kiosk, MGM Rewards Members will receive a Retail Therapy Shopping Dollars receipt providing the website that guests can access to redeem their Shopping Dollars.

9. Shopping Dollars can be accumulated throughout the month and redeemed online for a gift(s) of choice. Selected gift(s) will be delivered to the address provided when placing the order.
10. Required SLOT DOLLARS® is based on rated play and must be earned on the promotional date.
11. MGM Rewards Members can earn SLOT DOLLARS® by inserting their MGM Rewards Card into any functioning video gaming machine and registering play.
12. On promotional dates, invited members will receive a complimentary Shopping Dollar offer. Shopping Dollars issued are based on rated play.
13. MGM Rewards Member may redeem complimentary offer once per promotional date.
 - a. If promotional kiosks are unavailable, prizes may be issued via alternate methods or in extended periods. Effected winners may receive information on claiming prizes via traditional advertising methods.
