KIOSK GAME CONDUCT

6. On the promotional dates, MGM Rewards Members may play with MGM Rewards Card to 2X multiply entries for the \$595,000 High Stakes Showdown Drawings. Kiosk activation is not required. Based on same day earn.

7. Multiplied entries may take up to 24 hours to update on MGM Rewards Account.

Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion.
