GIFT CARD PROMOTION CONDUCT

5. MGM Rewards Members can earn SLOT DOLLARS® playing on any machine to receive a gift card or *FREEPLAY*® in incremental stages. Offer earn stages are as follows:
- a. Stage 1: Earn \$4 SLOT DOLLARS® to receive a \$10 gift card or *FREEPLAY*®.
 - b. Stage 2: Earn an additional \$4 SLOT DOLLARS® to receive an extra \$20 in gift card value or *FREEPLAY*®.

10. New MGM Rewards Members that sign up on the promotional date may be required to obtain their earned *FREEPLAY*® at an MGM Rewards Desk during operational hours.

11. Qualified guest must redeem a gift card ticket from any MGM Rewards Kiosk between the hours of 10am and 8pm. Ticket must be redeemed at the MGM Rewards Desk on the same business day. Gift Cards will be issued on a first come first serve basis.

12. Prizes will be distributed on a first-come, first-served basis, while supplies last.

13. MGM Rewards Member may redeem each denomination offer once per promotional date. *FREEPLAY*® is not valid on any electronic table games. *FREEPLAY*® for this promotion EXPIRES the same day it is redeemed.

- a. If promotional kiosks are unavailable, prizes may be issued via alternate methods or in extended periods. Effected winners may receive information on claiming prizes via traditional advertising methods.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
