



# OFFICIAL RULES

## \$160,000 Pinch Hitter Drawings

### Virtual Drawings

#### Fridays

#### April 2026

1. Empire City Casino by MGM Resorts will host the \$160,000 Pinch Hitter Drawings on Fridays in April. Drawings will take place from 6:00 PM through 10:00 PM.

2. Drawing Dates: Thursdays: April 3rd, 10th, 17th, and 24th.

#### ENTRANTS

3. Empire City Casino will host drawings for all MGM Rewards members Fridays in April 2026.

4. Participants may receive information about this promotion in several ways including, but not limited to their monthly mailer and traditional advertising methods.

5. **MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE.** MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in **TERMS AND CONDITIONS.**

#### ENTRY PERIOD

6. Each promotional date, Empire City Casino will host drawings for MGM Rewards Members every hour from 6:00 PM to 10:00 PM.

7. Five (5) MGM Rewards Members from each Tier will be drawn each hour.

8. MGM Rewards Member must earn \$1 Slot Dollar during the promotional gaming day on any eligible machine and are responsible for activating their entries by registering any carded rating within one (1) hour of each drawing time on the drawing date.

9. SLOT DOLLARS® must be earned on the promotional date.

#### GENERAL DRAWING CONDUCT

10. At each drawing to time winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracking station.
