1. Empire City Casino by MGM Resorts will host the \$575,000 Hot Summer Saturdays every Saturday in July and August 2026. Drawings will take place each hour from 6pm until 10pm.

ENTRANTS

ENTRY PERIOD

5. Entry into the promotion is active from June 27th, 2026 at 9:45:00pm until August 29, 2026 at 9:44:59 PM.
6. MGM Rewards Members will receive one FREE entry by visiting any Rewards Kiosk, good for one redemption during the promotion period.
7. MGM Rewards Member will receive an additional entry for every \$.25 SLOT DOLLARS earned on any slot machine or electronic table games during the entry period.
8. MGM Rewards Members are responsible for activating their entries by registering any carded rating within two (2) hours of each drawing time on the drawing date.
9. MGM Reward Members can earn triple entries each Tuesday in August.

GENERAL DRAWING CONDUCT

10. At each hourly drawing, winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracing station.

15. *FREEPLAY*® prizes will be uploaded to the winners' account within one hour of the win.
