



OFFICIAL RULES

\$520,000 License to Win Drawings Virtual Drawing Promotion Saturdays in September September 2025

1. Empire City Casino by MGM Resorts will host the \$520,000 License to Win Drawings every Saturday in September 2025. Drawings will take place each hour from 6pm until 10pm.

2. Drawing Dates: September 6th, 13th, 20th, and 27th.

ENTRANTS

3. MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS. NO PURCHASE NECESSARY.

4. Participants may receive information about this promotion in several ways including, but not limited to their monthly mailer and traditional advertising methods.

ENTRY PERIOD

5. Entry into the promotion is active from August 30, 2025 at 9:45:00pm until September 27, 2025 at 9:44:59 PM.

6. MGM Rewards Members will receive one FREE entry by visiting any Rewards Kiosk, good for one redemption during the promotion period.

7. MGM Rewards Member will receive an additional entry for every \$.25 Slot Dollars earned on any slot machine or electronic table games during the entry period.

8. MGM Rewards Members are responsible for activating their entries by registering any carded rating within two (2) hours of each drawing time on the drawing date.

GENERAL DRAWING CONDUCT

9. On Standard days from 6pm to 10pm, 30 winner's names will be drawn at the beginning of the hour to participate in spinning the prize wheel. 15 winners will be announced every 30 minutes. Same rules will apply to the 6pm to 9pm drawings on the grand prize days. At 10pm up to 20 winners will be drawn to play a slot tournament for the grand prize.

10. Winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracking station.

11. All Winning names will be drawn as early as 15 minutes prior to each hour to allow for proper verification.

12. Participants may not win more than once per drawing session. In the event of a duplicate winner, an alternate will be drawn until a total unique list of winners are drawn each hour.

13. Once winners' names are verified, the names will be announced via public address system on the gaming floor, displayed at the drawing location, and on the media pods located throughout the gaming floor, as technology is available.
