

# **OFFICIAL RULES**

\$125,000 Hot Summer Hot Seat **Virtual Drawing Promotion** Tuesdays in September September 2025

- 1. Empire City Casino by MGM Resorts will host the \$125,000 Hot Summer Hot Seat on Tuesdays in September 2025. Drawings will take place between 5:00 PM and 8:00 PM.
- 2. Drawing Date: September 2nd, 9th, 16th, 23rd, and 30th.

#### **ENTRANTS**

- 3. MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS.

### **ENTRY**

- 5. Each promotional date, Empire City Casino will host drawings for eligible MGM Rewards Members every hour from 5:00 PM to 8:00 PM.
- 6. Eligible MGM Rewards Members are responsible for activating their card by earning \$1 Slot Dollar on the day of the drawing and registering any carded rating within thirty (30) minutes of each drawing time on the drawing date.

#### **GENERAL DRAWING CONDUCT**

- 7. At each drawing time, winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracing station.
- 8. Winning names will be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.

- 10. Once winners' names are verified, the names will be announced via public address system on the gaming floor, displayed at the drawing location, and on the media pods located throughout the gaming floor, as technology is available.
