



# OFFICIAL RULES

## \$595,000 High Stakes Showdown

#### May 2026

1. Empire City Casino by MGM Resorts will host the \$595,000 High Stakes Showdown every Friday and Saturday in May 2026. Drawings will take place each hour from 6pm until 10pm.

#### ENTRANTS

3. MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS. NO PURCHASE NECESSARY.

#### ENTRY PERIOD

5. Entry into the promotion is active from April 25, 2025 at 10:45:00pm until May 30, 2026 at 9:44:59 PM.

6. MGM Rewards Members will receive one FREE entry by visiting any Rewards Kiosk, good for one redemption during the promotion period.

7. MGM Rewards Member will receive an additional entry for every \$.25 SLOT DOLLARS® earned on any slot machine or electronic table games during the entry period.

8. MGM Rewards Members are responsible for activating their entries by registering any carded rating within two (2) hours of each drawing time on the drawing date.

#### GENERAL DRAWING CONDUCT

9. At each hourly drawing, winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracing station.

10. Winning names will be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.
