TOURNAMENT RULES

1. Beau Rivage Resort & Casino guarantees the prize pool for this event will meet or exceed \$1,000,000.
2. Players will start the tournament with 75,000 in tournament chips including the voluntary staff add on.
3. Registration will open two-hours prior to the scheduled starting time of each Day 1(Group 2A-2C) and close at the beginning of level 15.
4. All blind levels will be 30 minutes.
5. On each Day 1(Group 2A-2C), play will continue until 12% (rounded down) of the field remains. All Day 2 players will cash in the tournament. Players must advance to Day 2 with chips in order to cash.
6. All players remaining from Group 2A-2C will resume play at 12:00pm on Wednesday, January 8, 2025.
7. Eliminated players may re-enter in each flight until the beginning of level 15.
8. Players are permitted to play multiple flights. Any player advancing to Day 2 more than once will carry over their largest chip stack and surrender their smaller chip stack. Players will receive a \$700 payout for their surrendered chip stack. All payouts for surrendered chip stacks will come directly from the prize pool and be removed prior to calculating final tournament prize payouts.
9. Players advancing to Day 2 more than once must notify tournament management when qualifying multiple times. Failure to notify tournament management may result in forfeiture of the \$700 payout.
10. All tournament prizes must be claimed by the completion of play for this event. Any tournament prizes not redeemed at the completion of the event will be forfeited and processed as unclaimed funds.
11. The \$500 buy-in will be allocated as follows; \$410 entry fee; \$60 administrative fee; \$30 voluntary staff add on.
12. A voluntary gratuity of \$30 for the staff will render each player eligible for a bonus of 30,000 in starting chips. The bonus tournament starting chips available are included in the starting chip amount listed in Rule #2. This is an optional gratuity that will be provided directly to the staff and will not be kept by the house. Beau Rivage will no longer withhold any portion of buy-ins for staff gratuities.

The Mississippi Gaming Commission reserves the right to investigate any and all complaints and disputes regarding tournaments, promotions, and drawings. Such disputes and complaints will be resolved in accordance with the Mississippi Gaming Control Act and Mississippi Gaming Commission Regulations. Management reserves the right to cancel, change, and modify the tournament, promotion or drawing with prior notification to the Mississippi Gaming Commission, but must do so at least (3) days prior to the commencement of the activity.
