General Rules

1. Each level will last twenty (20) minutes.
2. Players will start with 20,000 in tournament chips.
3. Players with pre-purchased seats will have their chips put in at the beginning of the tournament. Unseated alternates will have their chips put into play at Registration Close.
4. **Ante is posted by the Big Blind ONLY. Big Blind is posted prior to Ante.**
5. Players may buy-in and re-enter through the end of level 8. (Including Break) Tournament Surrender will be allowed on Level 8 break.
6. Twelve (12) minute breaks will be every 4 levels.
7. **ARIA will award as many seats as possible (1 for every 8 entries) into the \$1,600 NLH Event on Sunday, June 22nd, 2025. Players winning seats will have their chips put into play at the start of the tournament. Seats won have no cash value and are non-transferable.**
8. Any prize money short of a full seat will be paid to the last remaining player who does not win a seat.
9. \$20 of the \$240 Buy-In will be withheld for Entry Fee. \$20 of the \$240 will be withheld for Staff Fee. \$200 of each \$240 buy-in will go to prize pool.
10. Tournament will be played 9 handed, including Final Table.
11. **ARIA guarantees the Prize Pool to be at least 10 Seats (\$16,000)**
12. Management reserves the right to cancel or change tournaments.
13. Tournaments will use TDA rules.
14. Residents of foreign countries without a U.S. tax treaty will be subject to withholding.
15. All players must use their ID and Player's Club Card to enter the tournament.
