### ENTRANTS

3. MUST BE AN MGM REWARDS MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS. NO PURCHASE NECESSARY.

4. Participants may receive information about this promotion in several ways including, but not limited to their monthly mailer and traditional advertising methods.

5. Invitation for this event is based on rated play.

### KIOSK GAME CONDUCT

1. On kiosk game date, invited MGM Rewards Members can earn up to \$85 *FREEPLAY*® by earning SLOT DOLLARS® each promotional date. SLOT DOLLARS® needed to receive *FREEPLAY*® varies by prize amount.

2. SLOT DOLLARS® must be earned on the promotional date.

3. MGM Rewards Members can earn Rewards SLOT DOLLARS® by inserting their MGM Rewards Card into any functioning video gaming machine and registering play.

4. Invited and qualified guests may visit a Promotional Kiosk to redeem awards. Members will be required to enter pin number to access promotional awards.

5. Guest may swipe their MGM Rewards card and enter their PIN at any promotional kiosk to participate. Guests must select the correct promotion for the applicable award.

6. All awarded prizes will be *FREEPLAY*®. Guests that receive prizes of more than \$300 in value will be required to verify identity at the MGM Rewards desk. Valid identification will be required.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
