No Pre-Nomination Necessary - Just Enter On The Scheduled Date Of The Draw

FREE TO ENTER

Horses DO NOT have to enter in the opening leg of the series, but must carry the opening leg claiming price in the first leg in which they race, etc. *

If a horse is scratched from the opening leg of the series, it may race in a later leg, and carry the same claiming price it would have in the opening leg.

The top nine series money earners who race in <u>at least two</u> preliminary legs (no more than two horses per owner or trainer) will earn spots in the final. If less than nine horses enter the final who raced in at least two preliminary legs, then the top series money earners who raced in only one preliminary leg will be eligible to fill the open spots in the final that aren't already taken by horses who raced in at least two preliminary legs.

Ties for final spots will be drawn by lot. Consolation races will be held on the night of final if enough enter to fill.

*Horse's claiming tags in the series will be based upon how many legs in the series in which they have started. Horses making their first start in the series will carry the Leg 1 claiming tag. Horses making their second start in the series will carry the leg 2 claiming tag, etc. No horse will carry a claiming tag in the final (unless scratched in their prior start), even if they did not start in all three preliminary legs.

- 1) All Series conducted under the rules and regulations of the Ohio State Racing Commission, the United States Trotting Association and Northfield Park.
- 2) Post positions in all legs drawn by lot.
- 3) At the time of declaration, with the exception of championship legs and consolation, a horse must meet current qualifying standards at Northfield Park (official track variances allowed).
- 4) Declarations close in accordance with the current draw schedule at Northfield Park.
- 5) Consolation Races will be carded for horses that raced in the series, but did not have enough points to make the final, in classes with 7 or more entrants.
- 6) Northfield requires six separate betting interests in any event or it may be canceled.
- 7) In the event more than eleven enter any preliminary leg, the race will be split into divisions (maximum of ten horses per race if two or more divisions, at discretion of Director of Racing).
- 8) Northfield reserves the right to reject any entry, declare off the event if sufficient nominations are not received, and place any horse entered incorrectly into its proper class (all at discretion of Director of Racing).
- 9) Stall space for all nominees may be revoked at any time.
