



# OFFICIAL RULES

## \$155,000 MGM Rewards VIP Me Sweepstakes Virtual Drawings Fridays February 2026

1. Empire City Casino by MGM Resorts will host the \$155,000 MGM Rewards VIP Me Sweepstakes on Fridays in February. Drawings will take place from 5:30pm through 9pm.

2. Drawing Dates: February 6th, 13th, 20th, and 27th.

#### ENTRANTS

3. Empire City Casino will host drawings for all MGM Rewards members on Fridays in February 2026.

4. Participants may receive information about this promotion in several ways including, but not limited to their monthly mailer and traditional advertising methods.

5. **MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE.** MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS.

#### ENTRY PERIOD

6. Entry into the promotion is active from Friday at 10:00am until Friday at 8:44:59 PM each gaming week. Points reset each week.

7. Each promotional date, Empire City Casino will host drawings for MGM Rewards Members every hour from 5:30 PM to 9:00 PM.

8. Drawings for Sapphire and Pearl Members will take place at 5:30 PM, 6:30 PM, 7:30 PM, and 8:30 PM. Drawings for Gold, Platinum and Noir Members will take place at 6:00 PM, 7:00 PM, 8:00 PM, and 9:00 PM.

9. MGM Rewards Members are responsible for activating their entries by registering any carded rating within thirty (30) minutes of each drawing time on the drawing date.

10. MGM Rewards Member will receive an additional entry for every \$1 Slot Dollar earned on any slot machine or electronic table games on the drawing date.

#### GENERAL DRAWING CONDUCT

11. At each drawing time, winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracing station.

12. Winning names will be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.

#### GRAND PRIZE DRAWING PRIZES
