



# OFFICIAL RULES

## \$140,000 VIP Slots and Sparklers Hot Seat Virtual Drawing Promotion Thursdays in July July 2025

1. Empire City Casino by MGM Resorts will host the \$140,000 VIP Slots and Sparkler Hot Seat on Thursdays in July 2025. Tournaments will take place between 6:00 PM and 9:00 PM.

2. Drawing Date: July 3rd, 10th, 17th, 24th, and 31st

### ENTRANTS

3. MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS.

4. Participants may receive information about this promotion in several ways including, but not limited to their monthly mailer and traditional advertising methods.

### ENTRY

5. Each promotional date, Empire City Casino will host drawings for MGM Rewards Members every hour from 6:00 PM to 9:00 PM.

6. Eligible MGM Rewards Members are responsible for activating their card by earning \$1 Slot Dollar on the day of the drawing and registering any carded rating within thirty (30) minutes of each drawing time on the drawing date.

### GENERAL DRAWING CONDUCT

7. At each drawing time, winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracing station.

8. Winning names will be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.

9. Participants may not win more than once per drawing session. In the event of a duplicate winner, an alternate will be drawn until a total of 20 unique winners are drawn for 6:00 PM – 9:00 PM drawings.

10. Once winners' names are verified, the names will be announced via public address system on the gaming floor, displayed at the drawing location, and on the media pods located throughout the gaming floor, as technology is available.

11. Participants must be present to win. At each drawing, winners will have 10 minutes to claim their spot at the designated location. No alternates will be drawn.

12. Participants may win a total of four (4) times per drawing date and a total of twenty (20) times over the life of this promotion.

### PRIZES

14. Prizes will be determined by playing a slot tournament for 1 minute. Prizes are not valid on any electronic table games.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a video lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and prizes will be forfeited automatically.
