ENTRANTS

3. Empire City Casino will host drawings for all MGM Rewards members.

8. Earning for this drawing is open Monday through Thursday each week. Entries will not carry over to the following week.
9. 2 Drums will be placed at the Skyline on Thursday August 6th, 13th, 20th and 27th, each labeled with a designated prize category. Guests must print their paper entries from any MGM Rewards Kiosk each Thursday and drop them in the drum of choice. All entries do not need to be dropped for the same prize.

GENERAL DRAWING CONDUCT

11. 2 Drums will be placed at the Skyline on Thursday August 6th, 13th, 20th and 27th, from 10am – 8:15pm each labeled with a designated prize.
12. Select members will have access to a VIP Lounge in the Skyline from 4pm – 9pm.
13. At the drawing time, winner's names will be randomly selected from the drawing drum. Prizes will be awarded from top to bottom in the order the winners are drawn.
14. Winning names will be drawn as early as 15 minutes prior to the announcement to allow for proper verification.
