



OFFICIAL RULES

\$160,000 Tiger and Dragon Drawings and IGT Promo Points Race Qualified Card-In Drawing Fridays March 2025

1. Empire City Casino by MGM Resorts will host the \$160,000 Tiger and Dragon Drawings every Friday in March 2025, and IGT Promo Points Race on Friday, March 28th, 2025. Standard drawings will take place each hour from 4pm until 9pm. IGT Promo Points Race will take place at 10pm on Friday, March 28th, 2025.

ENTRANTS

ENTRY PERIOD

5. Each promotional date, Empire City Casino will host drawings for MGM Rewards Members every hour from 4:00 PM to 9:00 PM.

6. For Amazing Money Drawings, MGM Rewards Member must earn \$1 SLOT DOLLAR® during the promotional gaming day on any machine and are responsible for activating their entries by registering any carded rating within thirty (30) minutes of each drawing time on the drawing date.

7. IGT Promo Points Race earning period is open each gaming day Friday March 7th, 14th, and 21st and from 10:00 AM to 9:44:59 PM on Friday, March 28th.

8. For IGT Promo Points Race, points must be earned on IGT Machines during earning periods.

STANDARD DRAWING CONDUCT

9. MGM Rewards Members are responsible to ensure his or her MGM Rewards Card is properly inserted and registered into an eligible machine at the time of the promotion.

10. Drawings for Sapphire and Pearl Members will take place at 5:00 PM, 7:00 PM, and 9:00 PM. Drawings for Gold, Platinum and Noir Members will take place at 4:00 PM, 6:00 PM, and 8:00 PM.

11. At each drawing time, 50 winners' names will be randomly chosen from all eligible participants via computer-generated selection process at a designated player tracking workstation.
