

OFFICIAL RULES

Tier Credit Multiplier Kiosk Promotion Select Mondays in December December 2025

- 1. Empire City Casino by MGM Resorts will host the Tier Credit Multiplier in December 2025.

ENTRANTS

KIOSK GAME CONDUCT

- 6. On promotion date, MGM Rewards Members may visit an MGM Rewards kiosk to activate the 2x Tier Credit Multiplier for each date.
- 7. Bonus SLOT DOLLARS® are based on SLOT DOLLARS® earned on the promotional date. Offers and bonuses will not carry over to additional dates.
- 8. The following days should be eligible within time period 12/5 12/22/2025:
- Mondays Only: 12/1, 12/8, 12/15, and 12/22.
- Each eligible day includes Tier Credits earned during the calendar day Eastern Standard Time (EST)

- 9. MGM Rewards Members can earn Tier Credits by inserting their MGM Rewards Card into any functioning video gaming machine and registering play.
- 10. Bonus Tier Credits will appear on player account within 30 days of the promotional date.
- 11. Eligible MGM Rewards Members must be present to participate.

Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion.
