## **TOURNAMENT RULES**

1. Beau Rivage Resort & Casino guarantees the prize pool for this event will meet or exceed \$200,000.

2. Players will start the tournament with 50,000 in tournament chips including the voluntary staff add on.

- 3. Registration will open two-hours prior to the scheduled start time of Day 1 and close at the beginning of level 11.
- 4. All blind levels will be 50 minutes.
- 5. Day 1 play will continue until the conclusion of level 11.
- 6. All players remaining from Day 1 will resume play at 1:00pm on Monday, January 6, 2025.
- 7. One re-entry permitted per player.
- 8. Eliminated players may re-enter until the beginning of level 11.
- 9. All tournament prizes must be claimed by the completion of play for this event. Any tournament prizes not redeemed at the completion of the event will be forfeited and processed as unclaimed funds.

10. The \$2,000 buy-in will be allocated as follows; \$1,800 entry fee; \$150 administrative fee; \$50 voluntary staff add on.

11. A voluntary gratuity of \$50 for the staff will render each player eligible for a bonus of 20,000 in starting chips. The bonus tournament starting chips available are included in the starting chip amount listed in Rule #2. This is an optional gratuity that will be provided directly to the staff and will not be kept by the house. Beau Rivage will no longer withhold any portion of buy-ins for staff gratuities.

The Mississippi Gaming Commission reserves the right to investigate any and all complaints and disputes regarding tournaments, promotions, and drawings. Such disputes and complaints will be resolved in accordance with the Mississippi Gaming Control Act and Mississippi Gaming Commission Regulations. Management reserves the right to cancel, change, and modify the tournament, promotion or drawing with prior notification to the Mississippi Gaming Commission, but must do so at least (3) days prior to the commencement of the activity.
