\$400,000 Run It Back Drawings

March 2026

1. Empire City Casino by MGM Resorts will host the \$400,000 Run It Back Drawings on Thursdays and Fridays in March. Drawings will take place from 5:00 PM through 9:00 PM.

2. Drawing Dates: Thursdays and Fridays: June 5th, 6th, 12th, 13th, 19th, 20th, 26th, and 27th.

ENTRANTS

3. Empire City Casino will host drawings for all MGM Rewards members Thursdays and Fridays in March 2026.

4. Participants may receive information about this promotion in several ways including, but not limited to their monthly mailer and traditional advertising methods.

5. **MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE.** MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in **TERMS AND CONDITIONS.**

ENTRY PERIOD

6. Each promotional date, Empire City Casino will host drawings for MGM Rewards Members every hour from 6:00 PM to 10:00 PM.

7. The \$400,000 Run It Back Drawings earning period opens each gaming week from Monday at 10:00 AM to Friday at 9:44:59 PM. Entries expire weekly.

8. MGM Rewards Members are responsible for activating their entries by registering any carded rating within two (2) hours of each drawing time on the drawing date.

9. MGM Rewards Member will receive one (1) entry for every \$1 Slot Dollar earned on any slot machine or electronic table games during the earning period.

10. **SLOT DOLLARS®** must be earned within the earning period for the corresponding drawing dates that week.

GENERAL DRAWING CONDUCT

11. At each drawing time, winner's names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracing station.

12. Winning names will be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.

13. Participants may not win more than once per drawing session. In the event of a duplicate winner, an alternate will be drawn until a total of 10 unique winners are drawn for 6:00 PM – 10:00 PM drawings.

14. Once winners' names are verified, the names will be announced via public address system on the gaming floor, displayed at the drawing location, and on the media pods located throughout the gaming floor, as technology is available.

15. Participants must be present to win. At each drawing, winners will have 10 minutes to claim their spot at the designated location. No alternates will be drawn.

16. Participants may win a total of five (5) times per drawing date.

17. Prize amounts awarded are dependent on prize amounts claimed. There may be up to 50 total drawing winners per date. Total prizes of up to \$400,000 in **FREEPLAY®**.

PRIZE STRUCTURE

18. On drawing dates, 10 winners will be drawn each hour.

19. Prizes will be determined by spinning a prize wheel.

Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion.
