



## \$150,000 Lucky Table Mystery High Hands

January 1<sup>st</sup> 2026 – February 28<sup>th</sup> 2026

1. You must be at least 21 years of age to participate. The Promotional funds from every game will be a max of \$3 with \$1 being taken on the flop, \$20 pot size and \$30 pot size. The Promotion rake taken from each game pot will be placed in a drop box on the opposite side of the table from the House rake. The Promotion rake Drop box will be collected and counted in a manner consistent with the internal control procedures of the MGM Grand Poker Room. One hundred percent (100%) of the daily Promotion rake will be posted to the Promotion reserve account daily. The Promotion reserve account will be used to fund the High Hand payouts and other promotions.
2. Only Texas Hold'em cash games are eligible for the Lucky Table Mystery High Hands payouts. Cash games that do not add to the Promotion rake and all Daily Tournaments are excluded from live action promotions. The qualifying periods for the High Hand will be posted to Bravo Poker app and in the poker room. Hands will not qualify for the High Hand until the hand is face up on the felt and announced by the dealer. Hands do not have to go to showdown. Hands do not have to win the pot to qualify.
3. To qualify for the High Hand promotion, a hand must be a minimum of **Queens Full or Better** and utilize both player's hole cards. The player's best possible combination of five cards will determine the value of the High Hand. Players that tie the board will qualify. Once a qualifying hand has been established, any player that makes a higher-ranking hand during that period will eliminate the previous qualifier. Each qualifying one-hour period will have one (1) winner, at maximum. In the case of a tie for any prize payout positions, the players involved will split the prize evenly.
4. **The Envelope selection will “roll” to the following hour period if not “hit”. Ex/ If there is no qualifying winner during a period, the winner of the next period will draw TWO (2) envelopes from the drawing drum. There is no cap on rollovers.**
5. **High Hand Schedule:**
  - a. **Daily – 11:00am to 8:00pm**
6. Exactly 531 prize envelopes will be awarded during the promotional period, totaling approximately \$150,250. Wheel Spins have an average payout of \$250-\$260 per spin. “Lucky Table” envelopes will average a \$1,300 total payout.
  - a. **On December 31<sup>st</sup>, 2025, poker management will load 511 prize envelopes into the drawing drum, withholding twenty (20) “Lucky Table” envelopes to be loaded into the drawing drum on January 31st, 2026.**
  - b. **Once a player has won a High Hand Period, a poker supervisor will walk the player to the drawing drum. Each prize is sealed in a non-descript envelope. The guest will draw a random envelope to reveal the prize amount. Claimed envelopes/prizes will not be returned to the drawing drum. The running prize quantity remaining will be available on the Bravo Poker App and in the Poker Room.**
  - c. **If a qualifying period does not “Hit”, the winner of the following High Hand period will claim TWO (2) envelopes and so on, until a qualifying period produces a winner.**
  - d. **Any prizes left unclaimed for any reason will not be returned to the drum and the corresponding prize value will be replaced into the promotional reserve account.**
7. **\*\*Guests with 4 hours of live action play (minus lobby time) on a drawing day will have a 2x multiplier eligible for all Lucky Table Mystery High Hand payouts during the same calendar day\*\*. Those hours will reset each morning at 6:00am and will only apply to same day play. Exception – Rule 9D and 10E.**

8. Prize values and quantity:

9. “Lucky Table” Prize Breakdown –

- a. Winner = \$550
- b. Players at the winner’s table = \$100
- c. Players are considered eligible for the \$100 payout if their chips were on the felt when the envelope is opened.
- d. Only the winning player is eligible for a “Lucky Table” 2x multiplier payout.**

10. Wheel Spins

- a. Prizes ranging from \$100 to \$1,000.
- b. “Pay Table” – Winner receives \$200, all other players at the table receive \$50.
- c. “Neighbors” – Winner receives \$200, players seated to the direct left and right of the winner receive \$50.
- d. “Splash” – Winner receives \$200, all active games will receive a \$25 splash pot.
- e. Only the winning player is eligible for a “Lucky Table” 2x multiplier payout.**

11. In the rare event that all envelopes have been opened before the end of the promotional period, all qualifying periods will award \$200. If this promotion is interrupted or postponed for any reason, management will reschedule the qualifying periods, as needed until all envelopes have been opened.
12. Any discrepancies in the normal process of a hand including any discussion of possible High Hands, pot size, or solicitation to call a bet during the play of the hands, in the discretion of Management, may void the High Hand eligibility for that hand. Any player determined to be manipulating the high hand of the hour result may have their win voided or be removed from the poker room.
13. Poker Room employees are eligible to participate, on or off shift. Reduced rake games are eligible for promotions if a promotion rake is being taken and all other requirements are met.
14. Bomb pots will be eligible for promotions. If two community boards are agreed upon, promotions will be active for the top board, not the bottom board. The fundamental rules of the game cannot be altered for a bomb pot to be eligible for promotions. Ex/ If players agree to a PLO Bomb Pot in a NLH game, the bomb pot will not be eligible for any current live action promotions.
15. Players have the option to not put promotional winnings on the table but can add any amount of the promotional winnings to their stack at the time of the receipt of chips. Chips not in play must be removed from the table. Chips are not in play until received from the MGM Grand Poker Room staff.
16. IRS regulations require U.S. citizens to present valid identification and a social security number.
17. For U.S. Citizens, a 1099-MISC will be issued for all promotional winnings of \$600 or more and tournament winnings over \$5,000 will also have 24% withholding applied. Non-resident aliens without a tax treaty are subject to 30% withholding on 100% of all promotional winnings of \$600 or more and will be issued a 1042-S. The decisions of MGM Grand management regarding all aspects of this promotion are final and binding, subject to NRS 463.362 which governs this promotion. The MGM Grand reserves the right to modify or discontinue this promotion at any time.
