4. Participants may receive information about this promotion in several ways including, but not limited to their monthly mailer and traditional advertising methods.

5. MUST BE AN MGM REWARDS™ MEMBER TO PARTICIPATE. MGM Rewards membership is free to all patrons who are 21 years of age or older, unless excluded from eligibility as outlined in TERMS AND CONDITIONS.

ENTRY PERIOD

6. Eligible MGM Rewards Member will receive an entry for every \$1 SLOT DOLLARS® earned on any slot machine or electronic table games on the drawing date.

8. MGM Rewards Members are responsible for activating their entries by registering any carded rating within one (1) hour of each drawing time on the drawing date.

GENERAL DRAWING CONDUCT

9. At each hourly drawing, winner’s names will be randomly selected from all eligible participants via computer-generated selection process at a designated player tracing station.

10. Winning names will be drawn as early as 15 minutes prior to each hourly announcement to allow for proper verification.
