



1. Empire City Casino by MGM Resorts will host the \$170,000 September to Remember Slot Tournament on Thursdays in September. Drawings will take place from 5:30pm through 9pm.

2. Drawing Dates: September 4th, 11th, 18th, and 25th.

ENTRANTS
