TOURNAMENT RULES

1. Beau Rivage Resort & Casino guarantees the prize pool for this event will meet or exceed \$1,000,000.
2. Beau Rivage Resort & Casino guarantees the first-place prize for this event will meet or exceed \$250,000.
3. Players will start the tournament with 40,000 in tournament chips including the voluntary staff add on.
4. Registration will open two-hours prior to the scheduled starting time of each Day 1(Group 6A-6D) and close at the beginning of level 10 on each Day 1 (6A-6D).
5. All levels will be 50 minutes. Final Table levels will be 60 minutes.
6. Play will continue on Day 1 (Groups 6A-6C) until the completion of level 14. Play will continue on Day 1 (Group 6D) until the completion of level 8. Remaining players from Group 6D will resume play at 10:30am on Sunday, January 12, 2025, to complete levels 9-14. All remaining players from Groups 6A-6D will be combined and begin Day 2 play at 4:00pm on Sunday, January 12, 2025. Day 2 play will continue until the tournament reaches the final 4 tables or 2:00am, whichever occurs first. Final Day play of the Main Event will begin at 2:00pm in the Magnolia Ballroom on Monday, January 13, 2025, and continue until a winner is declared.
7. Tournament breaks will be at the discretion of the Tournament Director.
8. All tournament prizes must be claimed by the completion of play for this event. Any tournament prizes not redeemed at the completion of the event will be forfeited and processed as unclaimed funds.
9. The \$1200 buy-in will be allocated as follows; \$1,050 entry fee; \$100 administrative fee; \$50 voluntary staff add on.
10. A voluntary gratuity of \$50 for the staff will render each player eligible for a bonus of 15,000 in starting chips. The bonus tournament starting chips available are included in the starting chip amount listed in Rule #3. This is an optional gratuity that will be provided directly to the staff and will not be kept by the house. Beau Rivage will no longer withhold any portion of buy-ins for staff gratuities.

The Mississippi Gaming Commission reserves the right to investigate any and all complaints and disputes regarding tournaments, promotions, and drawings. Such disputes and complaints will be resolved in accordance with the Mississippi Gaming Control Act and Mississippi Gaming Commission Regulations. Management reserves the right to cancel, change, and modify the tournament, promotion or drawing with prior notification to the Mississippi Gaming Commission, but must do so at least (3) days prior to the commencement of the activity.
