SLOT TOURNAMENT

AUGUST 8-10, 2024

OVERALL TOURNAMENT RULES

1. Participation in the \$425,000 Lucky Fox Slot Tournament is limited to invited MGM Resorts International® MGM Rewards guests ("Participants"). The Tournament will take place at MGM Grand Las Vegas.
2. The \$425,000 Lucky Fox Slot Tournament will consist of two (2) separate, independent tournaments. One tournament will be played on Friday, August 9, 2024 (the "Friday Tournament") and one tournament will be played on Saturday, August 10, 2024 (the "Saturday Tournament") (each a "Daily Tournament," collectively, the "Tournament").
3. The Entry Fee for the Tournament will be \$2,500. The Entry Fee must be paid in full to MGM Grand Las Vegas by a valid major credit card by Thursday, July 25, 2024. The Entry Fee is refundable, in full, for any cancellations received prior to 5:00 p.m. Pacific Time on Thursday, August 1, 2024.
4. Participants are subject to all terms and conditions of MGM Rewards membership as outlined in the MGM Rewards rules.
5. Participants must be at least 21 years of age, be able to present proof of age with valid government-issued identification during the event, have paid the Entry Fee and have obtained a confirmation number for their reservation.
6. The Prize Structure is based on 60 total Participants in each Daily Tournament and may be adjusted based on the actual number of Participants.
7. Tournament Machines have an individual timer that will shut off upon malfunction. In the event a malfunction cannot be corrected, the Participant will be moved to a vacant Tournament Machine to play their round. In the event the Participant is unable to be moved to a vacant Tournament Machine during their round, the Participant will be accommodated at Management's Discretion. A complete session must be played on a single machine. One (1) single Participant must play an entire round.
8. No money, tokens, or coins will be required to play the Tournament Machines.
9. Either MGM Rewards member on a linked account may play for the registered Participant. Participants or their Proxy must be present at the Tournament Area ("Tournament Area") and play at all their assigned round times. Failure to be present at any round may eliminate the Participant from further participation in the Tournament.
10. There is no smoking or vaping inside the Tournament Area.

TOURNAMENT RULES

11. Each Participant will play in both the Friday Tournament and the Saturday Tournament.
 - a. Each Participant will play in one (1) session consisting of three (3) Rounds for each Daily Tournament. Each Round will last three (3) minutes.
 - b. Each session will have approximately thirty (30) Participants.
 - c. Participants must play in at least one (1) Round of a Daily Tournament to qualify for a prize in that Daily Tournament.
12. Tournament Play will take place on designated Tournament Machines. Only one (1) person may play per Tournament Machine, per Round.
13. A Participant's score is determined by the number of points registered on their assigned Tournament Machine at the end of the round ("Round Score"), regardless of what the credit meter reads.
14. Participants will receive their pre-assigned Tournament location and starting Round time at mgmresorts.com/mgmgrandslotevents ("Event Website") prior to the start of the event.
15. It is the Participant's responsibility to immediately notify the Tournament representative with questions or concerns that may arise during a round. Upon notification of a malfunction, Management will determine, at its sole discretion, whether to continue play or to replay a session.
 - a. Participants should continue to press the 'Max Bet' or 'Play' button as well as any additional gameplay features while they are awaiting a Tournament representative to assist them.
 - b. Minor pauses or delays are not considered a machine malfunction.
16. Final Daily Tournament Results will be based on each Participant's Daily Tournament Final Score. A Participant's Daily Tournament Final Score will be the aggregated total of either their two highest (2) Round Scores for that Daily Tournament, or their one (1) highest Round Score plus their Rebuy Round Score, whichever aggregated score is higher.
17. Except as provided below, if two (2) or more Participants have the same Daily Tournament Final Score, the tied Participants will equally split the sum total of the applicable prizes.
 - a. For example, if three (3) Participants tie for 2nd place, they would equally split the 2nd, 3rd and 4th place prizes; the next highest score would receive the 5th place prize amount.
 - b. In the event Participants have tied for a Daily Tournament's 1st Place Grand Prize, the tied Participants will play one (1) playoff Round. The playoff Round will last three (3) minutes. Additional playoff Rounds will be held as necessary to determine a single Participant as the 1st Place Grand Prize winner.
18. Any agreements between Participants concerning the sharing of Tournament Winnings are entered into solely by the Participants and are not endorsed by MGM Resorts International. MGM Resorts International will not enforce any of these types of agreements and will not be responsible if certain parties do not honor their agreements.
19. In the event of a Tournament Manager malfunction, the Tournament Prize Structure is considered payable if a minimum of two (2) Rounds of play have been completed.

HOLIDAY GIFT SHOPPE DRAWING RULES

20. The Holiday Gift Shoppe Drawing will be held during each round of Tournament Play, excluding the Rebuy Round and Bonus Round.
 - a. One (1) randomly selected Tournament Machine number will be drawn each round to determine which Participant will receive 200,000 Holiday Gift Shoppe Gift Points ("Gift Points"). The registered Participant at the corresponding Tournament Machine number will receive 200,000 Gift Points.
 - b. If a Participant or Participant's Proxy misses their Tournament round, they will not be eligible for the Holiday Gift Shoppe Drawing in that round. Drawing winners must be present when their name and/or machine number is called to receive the prize.
21. Gift Points are redeemable for merchandise, gift cards, and FREEPLAY at Holiday Gift Shoppe at the end of the year, subject to the MGM Rewards Holiday Gift Shoppe Promotional Rules available at www.mgmresorts.com/HGS.

REBUY ROUND

22. Participants may participate in an optional \$500 Rebuy Round. Participants are limited to one (1) Rebuy Round entry per Daily Tournament.
23. The \$500 Rebuy Round Fee must be paid with either cash or live MGM Resorts International gaming chips.
24. The Rebuy Round will consist of one (1) additional Round of play. Rebuy Round play will last three (3) minutes.
25. Up to two (2) Rebuy Round sessions will be held for each Daily Tournament after the conclusion of that Daily Tournament's tournament play.
26. Each Rebuy Round session will have a maximum of thirty (30) Participants.

27. The number of points registered on a Participant's assigned Tournament Machine at the end of their Rebuy Round will be that Participant's Rebuy Round Score, regardless of what the credit meter reads.
28. Participants may purchase a Rebuy Round entry up until the start of that Daily Tournament's second Rebuy Round session (pending space availability)

BONUS ROUND RULES

29. Only the Participants and their linked accounts are allowed to earn SLOT DOLLARS® or Table Games theoretical toward the Bonus Round. If a Participant's MGM Rewards is found to be in use by someone other than the Participant; the Participant and the linked account may have any SLOT DOLLARS® or Table Games theoretical accumulated during that session(s) voided and/or the Participant and linked account, if any, eliminated from the Tournament.
30. Eligible Participants may participate in a Bonus Round to be held at MGM Grand Las Vegas on Saturday, August 10, 2024.
31. Participants that earn a minimum of \$1,000 SLOT DOLLARS® or \$20,000 theoretical in Table Games at any Las Vegas MGM Rewards destination from 12:01 a.m. on Thursday, August 8, 2024 through 1:00 p.m. on Saturday, August 10, 2024 ("Earning Period") will be eligible to participate in the Bonus Round.
32. MGM Rewards earnings will not be combined for purposes of determining Bonus Round eligibility.
33. Participants and their linked MGM Rewards accounts are allowed to earn MGM Rewards SLOT DOLLARS®/ theoretical play towards Bonus Round eligibility. Linked accounts will not be combined for Bonus Round earning. If a Participant's MGM Rewards card is found to be in use by someone other than the Participant, the Participant and the linked account may have any points, accumulated during that session(s), voided and/or the Participant and linked account, if any, eliminated from the Tournament.
34. It is the responsibility of all Participants to ensure their MGM Rewards card is inserted properly in the participating slot machine.
35. It is the responsibility of all Participants to insert their MGM Rewards card at, or after, 12:01 a.m. on Thursday, August 8, 2024, and remove their card before 1:00 p.m. on August 10, 2024, for the SLOT DOLLARS® from their initial and final sessions of play to be included in the calculation for Bonus Round eligibility.
36. The player tracking system tracks the official time for this event and any session that begins before or ends after the Earning Period will result in all SLOT DOLLARS® during such session(s) being voided and of no effect.
 - a. It is the Participant's responsibility to ensure their table games ratings are recorded by MGM Resorts International's casino management system at, or after, 12:01 a.m. on Thursday, August 8, 2024 until 1:00 p.m. on Saturday, August 10, 2024 for eligible theoretical ratings to be included in the calculation of entry into the Bonus Round. They may do so by confirming their ratings with Table Games Operations at the conclusion of play.
37. Participants eligible to participate in the Bonus Round will play one (1) Round of play. Bonus Round play will last three (3) minutes.
38. Bonus Round sessions will take place at 4:30 p.m. and 4:45 p.m. on Saturday, August 10, 2024, or as soon thereafter as determined by Management due to unforeseen circumstances which may result in the delay of the Bonus Round. If the Participant arrives past the stated start time, the Participant may play out the rest of the match in the time left. Participants who do not show up for their scheduled Bonus Round will forfeit the missed Bonus Round and will be unable to make up the missed round. Failure to be present may eliminate the Participant from the Bonus Round.
39. The number of points registered on a Participant's assigned Tournament Machine at the end of their Bonus Round session will be that Participant's Bonus Round Score, regardless of what the credit meter reads.
40. The Participant with the highest Bonus Round Score will be awarded \$35,000 in *FREEPLAY*.
41. If two (2) or more Participants have the highest Bonus Round Score, the tied Participants will play one (1) additional three (3)-minute Round. Additional Rounds will be played as necessary until one Participant is determined to be the Bonus Round Winner.

CONTINGENT DRAWING RULES

42. In the event of a Tournament Manager malfunction a Contingent Drawing will be held. A separate Contingent Drawing will be held for each Daily Tournament and/or Bonus Round cancelled as a result of a Tournament Malfunction.
43. Each Participant will receive one (1) Drawing Entry in the Contingent Drawing.
44. Each Drawing Entry will have the Participant's first and last name printed on the ticket.
45. These physical tickets will be placed into a Drawing Vessel by a Marketing or Special Events Representative.
 - a. The first ticket drawn will receive the 1st Place Prize, the second ticket drawn will receive the 2nd Place Prize and tickets will continue being drawn until all prizes are distributed (see prize structure below).
46. Award of Gift Points During Tournament Manager Malfunction. In addition to prizes awarded per the prize structure, in the event of a Tournament Manager Malfunction Participants will be awarded Gift Points for the affected Daily Tournament. 200,000 Gift Points will be awarded to the number of tickets drawn that are reflected by multiplying the number of rounds in the affected Daily Tournament by the number of sessions in that Daily Tournament (both of which might vary depending on the total number of Participants). For example, if the Daily Tournament has two (2) rounds and there are three (3) total sessions (2x3=6), the 1st through 6th ticket drawn will receive 200,000 Gift Points. Gift Points will not be awarded for Rebuy Rounds or Bonus Rounds affected by the Tournament Manager Malfunction.
47. Drawing Entries are nontransferable.
48. Participants need NOT be present during the drawing to win.

General Rules:

49. Winners are solely responsible for any taxes and fees on their winnings and by entering the Tournament authorize the deduction of such taxes, if any, from the prize(s). U.S. Residents will be issued a W2-G tax form and non-U.S. Residents will be issued a 1042-S tax form.
50. All *FREEPLAY* prizes will be issued globally.
51. All *FREEPLAY* prizes will expire 18 months from the date of distribution.
52. Any prize won will be awarded to the primary registered Participant.
53. Employees and/or relatives of MGM Resorts International®, its subsidiaries and advertising agencies or representatives are ineligible to participate in the Tournament. MGM Resorts International reserves the right to cancel or change this event at its sole discretion and without prior notice.
54. Invited guests from any MGM Resorts International destination may enter the Tournament.
55. MGM Resorts International takes your safety seriously. Participants and guests are required to follow applicable health and safety policies and protocols.
56. Failure to adhere to the Tournament, MGM Rewards, or MGM Resorts International general rules, procedures, and policies may result in disqualification.
57. Participation in this event authorizes MGM Resorts International and its parent company, subsidiaries and affiliates, and their respective directors, officers, employees and agents (including, but not limited to, any of their advertising, marketing and/or public relations agencies), to use Participant's name, voice, likeness and/or photograph(s) for any promotional and/or advertising purposes, in any and all mediums (whether now existing or in the future created), without additional compensation of any kind and Participant agrees to sign a release granting such use to the aforementioned entities.
58. MGM Resorts International reserves the right to extend, alter and/or revoke *FREEPLAY* at its sole discretion and without prior notice.
59. MGM Resorts International shall be excused from all performance and or payment obligations when the ability to execute the aforementioned promotion has been impeded as a result of, or arising from, any of the following: governmental laws, regulations, orders, war, acts of terrorism, acts of nature, pandemic viruses, riots, civil disobedience; severe weather conditions including but not limited to tornadoes, hurricanes, ice storms, snow storms, and/or hail storms; state or national emergencies (hereinafter referred to as "Force Majeure conditions"). MGM Resorts International shall only be excused from their performance and/or payment obligations of said promotion during the duration of the Force Majeure condition. Executive management of MGM Resorts International shall retain the right to cancel, terminate, or postpone the Promotion in its sole discretion, due to Force Majeure conditions. Executive management of MGM Resorts International shall retain the right to reschedule,

or not reschedule the aforementioned Promotion in its sole discretion. The staff of MGM Resorts International shall use reasonable efforts to inform Promotion Participants of the cancellation, termination, or postponement of any Promotion, due to Force Majeure conditions.

60. The decisions of MGM Resorts International Management regarding all aspects of the Tournament are final and binding, subject to NRS 463.362, which governs the Tournament.

GRAND PRIZE

62. The Grand Prize for the Friday Tournament is a 2024 Land Rover Defender VIN 57829 with a manufacturer's suggested retail price of \$104,790.
63. The Grand Prize for the Saturday Tournament is the winner's choice of either (i) a 2024 Lotus Emira VIN 71149 (subject to delayed delivery) with a manufacturer's suggested retail price of \$96,050, or (ii) a 2024 Lotus Emira VIN 11239 (used with 125 miles), with an approximate retail value of \$96,000 (with original MSRP of \$109,150).
64. With respect to the two (2) winners of the Grand Prizes (automobiles), MGM Grand has paid MSRP and all sales taxes on both vehicles.
