

## XFL 20 Day Giveaway Sweepstakes

### OFFICIAL RULES

**NO PAYMENT, ENTRY FEE OR PURCHASE REQUIRED. OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES. ENTRANTS MUST BE AT LEAST EIGHTEEN (18) YEARS OLD AT TIME OF ENTRY. VOID WHERE PROHIBITED.**

**HOW TO ENTER.** The Twenty Day Giveaway Sweepstakes (the “Sweepstakes”) begins at 12:00 A.M. EST on January 29, 2023 and ends at 11:59 P.M. EST on February 18, 2023 (the “Entry Period”). The promotion is sponsored by XFL Properties LLC (the "Sponsor"). Sponsor’s clock is the official time keeping device of the Sweepstakes.

There is one method of entry (“Sweepstakes Entry Method”): Enter by visiting [www.xfl.com/20daygiveaway](http://www.xfl.com/20daygiveaway) during the Entry Period and following the instructions for the Sweepstakes provided therein to submit a completed entry form.

Limit one (1) entry per person per day during the Entry Period. Entrance into the Sweepstakes through multiple email accounts will disqualify entrant from the Sweepstakes. All entry materials become the property of the Sponsor and will not be acknowledged or returned. Each action completed earns the entrant one (1) entry in the Sweepstakes drawing as noted.

**NO PURCHASE NECESSARY.** A purchase will not increase your chances of winning.

**ELIGIBILITY.** This Sweepstakes is open only to natural persons who are legal residents of the United States of America, who are at least eighteen (18) years of age at the time of entry, and who have a valid email address. Employees, officers, directors and agents of Sponsor, its affiliates, subsidiaries, advertising and promotion agencies, and the immediate family members (meaning spouses, parents, siblings, children and their respective spouses) and members of the households of such employees, officers, directors and agents are not eligible. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email account will be deemed to be the entrant. Sponsor may request any potential winner to provide proof that such person is the winner. All potential winners are subject to verification before any prize will be awarded. Sponsor reserves the right to permanently disqualify from this Sweepstakes any person it believes has intentionally violated these Official Rules. **DRAWING.** The Winners (as defined below) will be selected at random from among all eligible entries received. The random drawings shall take place each day during the Entry Period by Sponsor, or its designee, whose decisions are final and binding on all aspects of this Sweepstakes and not subject to appeal. The potential winners will be contacted by email or phone within approximately one (1) business day after being selected. Potential winners will be required to claim his or her prize within two (2) business days of the time the winner notification is sent. To claim the prize, the winners must respond as directed in the message sent to the potential winners. Potential winners may be required to provide additional information to confirm identity

and eligibility and also may be required to complete and sign an Affidavit of Eligibility, a Liability Release and, where legal, a Publicity Release, and any other documentation that Sponsor may require and to see to it that Sponsor is in receipt of such information and documents within two (2) business days of being requested to provide the same. **PRIZES.** Twenty (20) winners (“Winners”) will each receive one (1) prize from Sponsor in the form of Sponsor merchandise, game tickets to Sponsor events, or other prizes as designated by the Sponsor in its sole discretion (the “Prizes”). Approximate retail value (“ARV”) of the Prizes range from \$20.00 USD to \$100.00 USD. The ARV is determined as of the date of the printing of these Official Rules. The difference in the value of the Prizes as stated herein and value at time of Prize notification, if any, will not be awarded.
