TEEN TECH TEAMS GRANT PROGRAM RULES

- Best Buy Teen Tech Teams Grant program (the "Best Buy Program") will review and select robotics teams to participate in Best Buy Program, which includes but is not limited to the provision of a cash donation of \$5,000 (five thousand) ("Cash Donation") by Best Buy Canada and ONE (1) Alienware Gaming Laptop by Dell Alienware (value of up to \$2499.99 CAD) to each of the selected teams.
- 2. No purchase is necessary to enter Best Buy Program. Best Buy Program is voluntary and the provision of 5,000 to the selected teams is donation. Any and all equipment purchased with the Cash Donation becomes the property of the selected robotics team.
- 3. The Program is open to all Canadian robotics teams who are registered to compete in the FIRST Robotics Competition (https://www.firstinspires.org/robotics/frc), with members range in age from 13 to 18 years old.
- 4. The Application form must be fully completed and approved by the robotics team's teacher or sponsor. For Best Buy Program, the applicable school district or organization will be required to execute the Best Buy Program Agreement. Best Buy Canada reserves the right to amend this agreement.
- 5. Only one application per robotics team for Best Buy Program can be submitted during each submission period.
- 6. The Cash Donation can only be used to purchase technology or equipment to build a robot for the FIRST Robotics Competition. Donation cannot be used to pay for travel.
- 7. Best Buy Program participation will be determined by a cross-sectional panel of Best Buy Canada employees. The panel will decide which robotics teams will be selected to participate in Best Buy Program based on the quality of the applications provided, the impact the new technology will have on the teens, and other considerations, including but not limited to: how the technology purchased with Cash Donation will inspire, motivate and empower teens; how the new technology will level playing fields for robotics teams; how many teens will be impacted by the Cash Donation; and the robotics team's need for resources. Decisions of the panel in respect of any aspect of Best Buy Program are final and binding on all participants.
- 8. The applicant and its applicable school board or organization may be contacted if additional information regarding the application is required.
- 9. Applicants will ensure that the proper permission and release documentation are received for the content of their application, images, including but not limited to intellectual property licenses and photographic image releases. Applicants agree to indemnify and hold Best Buy Canada, its parent, affiliates, subsidiaries, officers, and

- agents harmless from any and all claims relating to a breach of third-party intellectual property.
- 10. Applications for Best Buy Program will be accepted starting Friday May 24, 2024, and must be received by 11:59:59 p.m. PST on Friday, June 29, 2024 in order to be considered for Best Buy Program.
- 11. The selected applicants for Best Buy Program will be contacted by telephone or inperson on or before September 30, 2024. The selected participants for Best Buy Program will also be announced publicly in October 2024. By making an application to Best Buy Program, the participants agree to the public announcement of their selection for Best Buy Program.
- 12. The selected applicants must be available to participate in Best Buy Program and complete the purchase of technology with the Cash Donation no later than June 30, 2025. Participation includes but is not limited to providing access to Best Buy Canada to view the technology, and a list of contact persons at the applicable school or organization..
- 13. The selected participants of Best Buy Program will provide Best Buy Canada with a properly executed Best Buy Program Agreement no later than 30 days after the selection of the participant in Best Buy Program.
- 14. If a selected participant of Best Buy Program does not provide an executed Best Buy Canada Best Buy Program Agreement within the timeline set out below, that participant will be disqualified, and another participant will be selected by Best Buy Program selection committee.
- 15. By entering Best Buy Program, the participants agree to Best Buy Canada's disclosure of their participation in the Program, including but not limited to including the robotics team's name in the list(s) of Best Buy Program participants.
- 16. Best Buy Canada and its parents, subsidiaries and affiliates will not, under any circumstances, be responsible for, or liable to any Best Buy Program participant or any other person for:
 - a. any erroneous, lost, damaged, late, incomplete, misdirected, deleted, defective, or altered Program entries, regardless of the cause;
 - b. any failure for any reason whatsoever of the selected participant to receive Best Buy Program participation acceptance notification;
 - c. any changes in email addresses or email address assignments or telephone numbers after Best Buy Program entry forms are submitted;
 - d. any computer, online, telephone, or technical malfunctions or errors that may occur, regardless of the cause; or

- e. any damage or loss, including any loss of use, loss of production, loss of profits (anticipated or otherwise), loss of markets, economic loss, special, indirect or consequential loss or damage or punitive damages, whether in contract, tort or under any other theory of law or equity, arising from, connected with, or relating to the Program or the submission of entries to Best Buy Program or participation in the Program, or the use of the www.bestbuy.ca web site (including the downloading of any materials from that web site) and regardless of the cause or any negligence by Best Buy Canada or anyone for whom Best Buy Canada is responsible, and notwithstanding that Best Buy Canada may have been advised of the possibility of such loss or damage being incurred.

If for any reason Best Buy Program is not capable of being conducted as intended by Best Buy Canada, including due to computer viruses, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other cause that corrupts or interferes with the administration, security, fairness, integrity or proper conduct of the Program, Best Buy Canada may, at its sole discretion, disqualify any participant responsible for such misconduct and cancel, terminate, modify, or suspend Best Buy Program.
