

April 2020 Standard Chartered Credit Cards Standard Promotion Terms & Conditions

1. The **April 2020 Standard Chartered Credit Cards Promotion** (hereinafter referred to as “CCSP2004SC-Promotion”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Standard Chartered Bank Malaysia Berhad (115793-P) (hereinafter referred to as “Standard Chartered”) as a Service Provider for bank products that are being applied for.
2. Standard Chartered credit cards eligible for CCSP2004SC-Promotion are Standard Chartered Visa Platinum Card, Standard Chartered WorldMiles World Mastercard® and Standard Chartered JustOne Platinum Mastercard® (hereinafter referred to as “**Eligible Credit Cards**”).

Promotion Period

3. The CCSP2004SC-Promotion comprises of the following periods:
 - a. “**Sign-Up Period**” runs from 24 April 2020 to 31 May 2020, both dates inclusive;
 - b. “**Redemption Period**” runs from 23 May 2020 to 31 August 2020, both dates inclusive;

Promotion Eligibility

4. The CCSP2004SC-Promotion is open to individuals who are:
 - a. 21 years old and above; and
 - b. Having a residential address in Peninsular Malaysia; and
 - c. is either a New-to-Bank or New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Standard Chartered.
 - ii. New-to-Card is defined as an existing bank customer who does not hold any active credit card/s from Standard Chartered.
 - d. must register interest, during the Sign-Up Period, for any of the Eligible Credit Cards on CompareHero.my website, to get redirected to Standard Chartered website; and
 - e. completes the Standard Chartered online application process before the end of the Sign-Up Period; and
 - f. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “**Cardholder/s**”) within thirty (30) days from the end date of the promotion.
5. The following individuals are not eligible for the CCSP2004SC-Promotion:
 - a. permanent and/or contract employees of Standard Chartered (including its subsidiaries and related companies) and their respective immediate family members; and/or
 - b. representatives and/or agents (including advertising and campaign agents) of Standard Chartered and their respective immediate family members; and/or
 - c. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCSP2004SC-Promotion; and/or
 - d. any individuals who had cancelled any of his/her Standard Chartered credit card within six (6) months before the date of application and is re-applying for any Standard Chartered Credit Card under the CCSP2004SC-Promotion; and/or
 - e. present holders of any Standard Chartered credit card(s) whether issued in Malaysia or otherwise; and/or
 - f. any person who has committed or suspected of committing any misconduct, fraudulent or wrongful acts in relation to their card account(s), any facility, service or accommodation granted by Standard Chartered, including Standard Chartered Online (Website); and/or
 - g. those who apply for any of the Eligible Credit Cards via other methods from Clause 4(c) and 4(d).
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5, and its subclauses) within forty-five (45) days will be considered a “**Successful Cardholder**” of the CCSP2004SC-Promotion.
8. Each Successful Cardholder is entitled to only one (1) CCSP2004SC-Promotion gif (hereinafter referred to as “**Promotion Gift**”), regardless of the number of approved and activated Eligible Credit Cards from Standard Chartered.
9. Promotion Gift is defined as a single unit (1 unit) of SHARP KQA60RD Pressure Cooker.

10. Successful Cardholders who receive the Promotion Gift are not able to participate in other sign-up card campaigns, promotions or offers by Standard Chartered or its third-party sales agents.
11. Successful Cardholders without a residential address in Peninsular Malaysia will be issued a “**Substitute Gift**” instead.
 - a. Substitute Gift is defined as a RM200 Lazada eVoucher and request for other options will not be entertained.

Promotion Gift Redemption

12. For the avoidance of doubt, it is the Successful Cardholder’s responsibility to redeem the Promotion Gift or Substitute within their respective Redemption Periods.
13. CompareHero.my will contact all Successful Cardholders to redeem the Promotion Gift or Substitute Gift, between 4-8 weeks after card activation (pending official Standard Chartered reports):
 - a. via email (email address in CompareHero.my’s record) with gift redemption instructions; and/or
 - b. via SMS (mobile phone number in CompareHero.my’s record).
14. The Promotion Gift or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
15. The Promotion Gift or Substitute Gift is considered redeemed when a Successful Cardholder responds to the gift redemption email instructions before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no Promotion Gift will be issued.
16. Delivery or fulfilment of Promotion Gift or Substitute Gift is estimated to be 4 weeks from redeemed date (pending stock availability, and/or merchant delivery schedules).
17. The Promotion Gift or Substitute Gift choice of size, technical specifications and/or colour is at the discretion of CompareHero.my, based on available stock from the merchant/s. CompareHero.my can replace the Promotion Gift or Substitute Gift with something of equivalent or higher value if the merchant/s runs out of stock.
18. The Promotion Gift or Substitute Gift does not include any accessories or items (unless stated) that may be shown on any marketing materials, as they are for illustration purposes only.
19. The use of the Promotion Gift or Substitute Gift is subject to terms and conditions of the issuing merchant/s. All additional terms and conditions will be stated in full, upon delivery or fulfilment of Promotion Gift. Additional terms and conditions may include validity dates, spend requirements, applicable or exclusion products and other conditions. The issuing merchant/s reserves the right to alter, cancel, terminate or suspend the order or any part thereof or any part of the applicable terms and conditions from time to time, with or without any prior notice.
20. All servicing or warranty claims should be directed to the merchant, manufacturer or distributor of the Promotion Gift or Substitute Gift. Please refer to the warranty card / box / notification attached with the Promotion Gift.
