

April 2022 Standard Chartered Credit Cards Standard Campaign Terms & Conditions

1. The **April 2022 Standard Chartered Credit Cards Standard Campaign** (hereinafter referred to as “**CCSC2204SC2-Campaign**”) is organized by Compargo Malaysia Sdn Bhd [201301020939 (1050769-U)] for CompareHero.my (hereinafter referred to as “**CompareHero.my**” or “**we**”) and in partnership with Standard Chartered Bank Malaysia Berhad [198401003274 (115793-P)] (hereinafter referred to as “**Standard Chartered**”) as a Service Provider for bank products that are being applied for.
2. **Standard Chartered** credit cards eligible for **CCSC2204SC2-Campaign** are Standard Chartered WorldMiles Mastercard®, Standard Chartered Visa Platinum, Standard Chartered Liverpool FC Cashback Credit Card, Standard Chartered Smart Credit Card, and Standard Chartered JustOne Platinum Mastercard® (hereinafter referred to as “**Eligible Credit Cards**”).

Campaign Period

3. The **CCSC2204SC2-Campaign** comprises of the following periods:
 - a. “**Sign-Up Period**” runs from **21 April 2022** to **31 May 2022**, both dates inclusive;
 - b. “**Redemption Period**” runs from **1 July 2022** to **31 October 2022**, both dates inclusive.

Campaign Eligibility

4. The **CCSC2204SC2-Campaign** is open to individuals who:
 - a. are 21 years old and above; and
 - b. have a residential address in Peninsular Malaysia for receiving a Campaign Gift as defined below OR having a residential address outside Peninsular Malaysia for receiving a Substitute Gift as defined below; and
 - c. are either a New-to-Bank or a New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any existing and/or prior accounts or a financial relationship with Standard Chartered whether in Malaysia or otherwise.
 - ii. New-to-Card is defined as an existing Standard Chartered customer who does not hold any active credit card/s from Standard Chartered whether issued in Malaysia or otherwise. In any event, New to-Card does not include any individual who had cancelled any of his/her Standard Chartered credit card within six (6) months before the date of application and is re-applying for any Standard Chartered Credit Card under the **CCSC2204SC2-Campaign**.
 - d. register their interest, during the Sign-Up Period, for any of the Eligible Credit Cards on CompareHero.my website, to get redirected to Standard Chartered website; and
 - e. completes the Standard Chartered online application process before the end of the Sign-Up Period; and
 - f. has their application for the Eligible Credit Cards approved by Standard Chartered (hereinafter referred to as “**Cardholder/s**”) and activates the Eligible Credit Card within **thirty (30) days** from the date of approval of the Eligible Credit Card.
5. The following individuals are not eligible for the **CCSC2204SC2-Campaign**:
 - a. permanent and/or contract employees of Standard Chartered (including its subsidiaries and related companies) and their respective immediate family members; and/or
 - b. representatives and/or agents (including advertising and campaign agents) of Standard Chartered and their respective immediate family members; and/or
 - c. any person who has committed or suspected of committing any misconduct, fraudulent or wrongful acts in relation to their credit card account(s), any facility, service, or accommodation granted by Standard Chartered, including Standard Chartered Online (Website); and/or

- d. those who have registered for a previous credit card campaign organized by CompareHero.my within the three (3) months preceding the start date of **CCSC2204SC2-Campaign**. It is clarified that any such individual will not be eligible for this **CCSC2204SC2-Campaign** irrespective of whether their Eligible Credit Card application made under the previous Campaign with CompareHero.my has been completed and/or approved by Standard Chartered.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and/or social media if we deem it not legible, in non-English alphabets, to use foul language, or suspect it as spam or of a fraudulent nature.

Campaign Mechanics

7. Cardholders who fulfil the Campaign Eligibility requirements set out in clauses 4 and 5, and their subclauses above, will be considered a **“Successful Cardholder”** of the **CCSC2204SC2-Campaign**.
8. Successful Cardholders with a residential address in Peninsular Malaysia shall be entitled to receive one (1) **“Campaign Gift”**. Campaign Gift is defined as **One (1) unit of Sharp HP-TW10 True Wireless Splashproof Stereo Earphones worth RM399 (recommended retail value)**.
9. Successful Cardholders without a residential address in Peninsular Malaysia will not be eligible to receive the Campaign Gift but will be issued one (1) **“Substitute Gift”** instead. Substitute Gift is defined as **Shopee eVoucher(s) with total worth of RM150**.
10. Each Successful Cardholder may be entitled to and shall only receive one (1) Campaign Gift or one (1) Substitute Gift, as applicable, regardless of the number of approved and activated Eligible Credit Cards issued by Standard Chartered.
11. Successful Cardholders with a residential address in Peninsular Malaysia will receive one (1) Campaign Gift following receipt of the Redemption Message (as defined below) from CompareHero.my confirming their eligibility for gift redemption.
12. Successful Cardholders who receive the Campaign Gift or the Substitute Gift, as applicable, shall not be eligible to participate in other sign-up card campaigns, promotions or offers by Standard Chartered or its third-party sales agents.

Campaign Gift Redemption

13. For the avoidance of doubt, it is the Successful Cardholder’s responsibility to redeem the Campaign Gift or Substitute Gift within the Redemption Period.
14. CompareHero.my will contact all Successful Cardholders to redeem the Campaign Gift or Substitute Gift between **1 July 2022 to 30 September 2022 (“Redemption Message”)** via:
 - a. email (email address in CompareHero.my’s record) with gift redemption instructions; and/or
 - b. SMS (mobile phone number in CompareHero.my’s record).
15. The Campaign Gift or Substitute Gift cannot be transferred to other parties, is not refundable and are strictly not exchangeable for cash, credit, or other goods.
16. Delivery or fulfilment of Campaign Gift or Substitute Gift is estimated to be four (4) weeks from the date on which the Successful Cardholder has responded to the Redemption Message (**“Fulfilment Period”**) (subject always to availability of third-party distribution and supply channels, stock availability and/or merchant delivery schedules, over which we have no control). CompareHero.my is not responsible for any wrongful or missing delivery or fulfilment of the Campaign Gift or Substitute Gift due to any incorrect or incomplete address or mobile number supplied by the Successful Cardholder. No replacement of Campaign Gift and/or Substitute Gift will be offered in such event.
17. The Campaign Gift or Substitute Gift is considered redeemed when a Successful Cardholder responds to the Redemption Message instructions before the end of the Redemption Period (**“Redeemed Date”**). Any attempt of gift redemption after the Redemption Period will not be entertained and no Campaign Gift or Substitute Gift will be

issued.

18. CompareHero.my reserves the right to disqualify applicants who have failed to fulfil the **CCSC2204SC2-Campaign** Campaign Terms and Conditions and/or who have submitted incomplete or inaccurate data, without prior notice.
19. The Campaign Gift or Substitute Gift choice of size, technical specifications and/or colour is at the discretion of CompareHero.my, based on available stock from the merchant/s. CompareHero.my can replace the Campaign Gift or Substitute Gift with something of equivalent or higher value if the merchant/s runs out of stock.
20. The Campaign Gift or Substitute Gift does not include any accessories or items (unless stated) that may be shown on any marketing materials, as they are for illustration purposes only.
21. The recommended retail value of the gifts provided above is for reference purposes only and is subject to change by the issuing merchant, over which CompareHero.my has no control.
22. The use of the Campaign Gift or Substitute Gift is subject to terms and conditions of the issuing merchant/s. All additional terms and conditions will be stated in full, upon delivery or fulfilment of Campaign Gift or Substitute Gift. Additional terms and conditions may include validity dates, spend requirements, applicable or exclusion products and other conditions. The issuing merchant/s reserves the right to alter, cancel, terminate or suspend the order or any part thereof or any part of the applicable terms and conditions from time to time, with or without any prior notice.
23. All servicing or warranty claims should be directed to the merchant, manufacturer or distributor of the Campaign Gift or Substitute Gift. Please refer to the warranty card / box / notification attached with the Campaign Gift or Substitute Gift.
24. CompareHero.my and Standard Chartered are not in any way endorsing, sanctioning, approving or supporting the brand/s or merchandise of the Campaign Gift or Substitute Gift and are in no manner responsible for any issues related to the usage of the Campaign Gift and/or Substitute Gift. Any query and/or dispute on the usage of the Campaign Gift or Substitute Gift must be directed to, and resolved directly with the issuing merchant/s.
25. Campaign Gift or Substitute Gift brand/s or merchandise are not a participant in or sponsor of this **CCSC2204SC2-Campaign**. The brand/s logo and/or trademarks remains the intellectual property of the brand.
26. By accepting the Campaign Gift or Substitute Gift, the Successful Cardholder agrees to give CompareHero.my the discretion to publish their name and masked phone number in a list on all CompareHero.my's website, social media accounts and communication platforms.

General Campaign Terms and Conditions

27. The use of the CompareHero.my website and services constitutes the acceptance of the general [Terms and Conditions](#) and [Privacy Policy](#).
 - a. For the avoidance of doubt, during the course of using CompareHero.my services, individuals that have registered their interest and/or have applied for a Standard Chartered product listed on CompareHero.my, are deemed to have given explicit consent to the collection, use and sharing of their personal data between CompareHero.my and Standard Chartered, for the purposes of the administration of this Campaign, including application status, card activation status, and other qualifying criteria.
28. CompareHero.my reserves the right to (at its own discretion) disqualify any participant and/or withhold or confiscate in full or part any Campaign Gift or Substitute Gift if:
 - a. the participant is found to be, or reasonably suspected of participating in any form of fraudulent practices (including but not limited to false identities, doctoring images, wilful spamming or manipulation of any CompareHero.my's processes, or website); and/or
 - b. the redemption request is found to have been made via other channels, made outside of the Redemption Period, or are fraudulent, against the spirit of the Campaign, or non-compliant with the Campaign terms and conditions.
29. In the event of disputes, CompareHero.my's decision shall be final.

30. Where we suspect a participant is participating in any form of unlawful and/or fraudulent activity, we reserve the right to report such activity or suspicions to the police or relevant authorities.
31. Applications for the Eligible Credit Cards received after the end of the Sign-Up Period as set out in Clause 3(a) above will not be eligible to participate in the **CCSC2204SC2-Campaign**. All applicants under **CCSC2204SC2-Campaign** are required to complete the application for the Eligible Credit Cards online on Standard Charter Bank's website, which the applicant will be redirected to upon completion of registration on the CompareHero.my website.
32. Final approval of any Eligible Credit Card is determined by the relevant banks in their absolute discretion and is subject to the banks' credit and risk processing criteria. Participating in this Campaign does not guarantee the approval of any Credit Card. CompareHero.my does not guarantee the approval of any Eligible Credit Card.
33. CompareHero.my reserves the right as it deems fit to vary or change any of these Campaign terms and conditions from time to time or cancel, terminate, withdraw, suspend and/or replace this Campaign with another similar Campaign with prior notice. Such variation, changes, cancellation, termination, withdrawal, suspension and/or replacement will be notified by posting on CompareHero.my website, social media or in any other manner as CompareHero.my deems fit.
34. CompareHero.my reserves the right to change the Sign-up Period or the Redemption Period if the launch of the Campaign is delayed and shall have no liability for the same.
35. In this respect, the participants of this Campaign also signifies their agreement to access the CompareHero.my website and/or social media at regular intervals to view these terms and conditions and to ensure that they are kept up-to-date with any variations or changes which CompareHero.my may effect from time to time. Participants also agree that their continued participation in this Campaign will constitute their acceptance of these terms and conditions (as varied from time to time).
36. Any cancellation, termination, withdrawal or suspension by CompareHero.my of this Campaign will not entitle participants to any compensation against CompareHero.my for any and all loss or damage that may be suffered or incurred by the participant as a direct or indirect result of the act of cancellation, termination, withdrawal or suspension.
37. The decisions of CompareHero.my and Standard Chartered in relation to every aspect of the Campaign, including but not limited to the definition of Successful Cardholders, shall be deemed final and conclusive under any circumstance and no further appeal, enquiry and/or correspondence will be entertained.
38. These Campaign terms and conditions are governed by and construed under the laws of Malaysia.
