

## November 2021 CIMB Bank Credit Cards Flash Deal Campaign Terms & Conditions

1. The **November 2021 CIMB Bank Credit Cards Flash Deal Campaign** (hereinafter referred to as “**CCFD2111CI-Campaign**”) is organized by Compargo Malaysia Sdn Bhd [201301020939 (1050769-U)] for CompareHero.my (hereinafter referred to as “**CompareHero.my**” or “we”) and in partnership with CIMB Bank Malaysia Berhad [198401003274 (115793-P)] (hereinafter referred to as “**CIMB**”) as a Service Provider for bank products that are being applied for.
2. CIMB credit cards eligible for **CCFD2111CI-Campaign** are CIMB e Credit Card, CIMB Cash Rebate Platinum Credit Card, CIMB PETRONAS Platinum Credit Card, CIMB Enrich Platinum Credit Card, CIMB Platinum Credit Card, CIMB World Mastercard Credit Card, CIMB Visa Signature Credit Card, CIMB Visa Infinite Credit Card, CIMB Enrich World Credit Card, CIMB Enrich World Elite Credit Card, CIMB Platinum-i Credit Card, and CIMB PETRONAS Platinum-i Credit Card (hereinafter referred to as “**Eligible Credit Cards**”).

### Campaign Period

3. The **CCFD2111CI-Campaign** comprises of the following periods:
  - a. “**Sign-Up Period**” runs from **24 November 2021** to **28 November 2021**, both dates inclusive;
  - b. “**Spend Period**” is defined as the earlier of:
    - i. **sixty (60) days** from the date of approval of the Eligible Credit Card; OR
    - ii. until **31 January 2022**
  - c. “**Redemption Period**” runs from **20 December 2021** to **31 March 2022**, both dates inclusive.

### Campaign Eligibility

4. The **CCFD2111CI-Campaign** is open to individuals who:
  - a. 21 years old and above; and
  - b. have a residential address in Peninsular Malaysia for receiving a Campaign Gift or Consolation gift as defined below OR having a residential address outside Peninsular Malaysia for receiving a Substitute Gift as defined below; and
  - c. are either a New-to-Bank or New-to-Card, applicant; and
    - i. New-to-Bank is defined as a person who does not have any existing and/or prior accounts or a financial relationship with CIMB whether in Malaysia or otherwise.
    - ii. New-to-Card is defined as an existing CIMB customer who does not hold any active credit card/s from CIMB, whether issued in Malaysia or otherwise. In any event, New-to-Card does not include any individual who had cancelled any of his/her CIMB credit card within six (6) months before the date of application and is re-applying for any CIMB Credit Card under the **CCFD2111CI-Campaign**.
  - d. register their interest, during the Sign-Up Period, for any of the Eligible Credit Cards on CompareHero.my website, to get redirected to CIMB website; and
  - e. completes the CIMB online application process before the end of the Sign-Up Period; and
  - f. have their application for the Eligible Credit Cards approved by CIMB (hereinafter referred to as “**Cardholder/s**”), activates and performs at least four (4) transactions qualifying as **Eligible Spends** (as defined below) using the Eligible Credit Card within the **Spend Period**
  - g. Eligible Spend of the **CCFD2111CI-Campaign** is defined as spends of any amount on any goods/services with the use of the Eligible Credit Card. Eligible Spend shall include local and/or overseas payment charged to the Eligible Credit Card during the Spend Period. For the avoidance of doubt the following transactions are herein expressly excluded and shall not be treated as an Eligible Spend:

- i. Quasi Cash transactions – the purchase of foreign currencies or items (including, but not limited to, casino chips, cryptocurrencies, money orders, lottery tickets and travellers cheques) which may be convertible to cash, and other such transactions as determined by CIMB from time to time..;
- ii. Monthly instalments under any instalment payment facility provided by CIMB or any other financial institutions or funds transfer from other Financial Institutions;
- iii. Payment of annual fees or service charges, delivery charges, cash payments, card replacement fees, dispute charges, fraud charges or any other fees, charges or penalties whether imposed by CIMB or otherwise;
- iv. Cash advance/withdrawal/deposit transactions;
- v. Eligible Spend which is subsequently cancelled or refunded, or any other disputed, unauthorized, or fraudulent transactions.

Any determination by CIMB as to what constitutes an Eligible Spend shall be conclusive.

5. The following individuals are not eligible for the **CCFD2111CI-Campaign**:
  - a. permanent and/or contract employees of CIMB (including its subsidiaries and related companies) and their respective immediate family members; and/or
  - b. representatives and/or agents (including advertising and campaign agents) of CIMB and their respective immediate family members; and/or
  - c. any person who has committed or suspected of committing any misconduct, fraudulent or wrongful acts in relation to their credit card account(s), any facility, service, or accommodation granted by CIMB, including CIMB Online (Website); and/or
  - d. those who have registered for a previous credit card campaign organized by CompareHero.my within the three (3) months preceding the start date of **CCFD2111CI-Campaign**. It is clarified that any such individual will not be eligible for this **CCFD2111CI-Campaign** irrespective of whether their Eligible Credit Card application made under the previous campaign with CompareHero.my has been completed and/or approved by CIMB.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and/or social media if we deem it not legible, in non-English alphabets, to use foul language, or suspect it as spam or of a fraudulent nature.

### Campaign Mechanics

7. Cardholders who fulfil the Campaign Eligibility requirements set out in clauses 4 and 5, and their subclauses above, will be considered a **“Successful Cardholder”** of the **CCFD2111CI-Campaign**.
8. Each Successful Cardholder may be entitled to and shall only receive one (1) Campaign Gift or one (1) Consolation Gift or one (1) Substitute Gift, as applicable, regardless of the number of approved and activated Eligible Credit Cards issued by CIMB.
9. Successful Cardholders:
  - a. with a residential address in Peninsular Malaysia will be in the running to receive one (1) “Campaign Gift”. Campaign Gift is defined as either one of the following:
    - i. **one (1) unit of Marshall Emberton Black & Brass worth RM799 (recommended retail value);** OR
    - ii. **one (1) Shopee eVoucher worth RM600**
  - b. without a residential address in Peninsular Malaysia will be in the running to receive one (1) Campaign Gift of RM600 Shopee eVoucher. Successful Cardholders without a residential address in Peninsular Malaysia are **not** eligible to receive the Marshall Emberton Black & Brass.

10. Successful Cardholders will be sorted by application date in chronological order (i.e. from earliest to latest) and each Successful Cardholder that is listed in the following positions: first, fifth, ninth, thirteenth, seventeenth and so on, shall be eligible to receive a **Campaign Gift** as set out in clause 9 above (together the “**Winners**” and each a “**Winner**”), up to a maximum of **40 winners**. The selection of the Winners as set out above shall be done by CompareHero.my, not CIMB, and the final determination of such Winners shall be made by CompareHero.my in its absolute discretion.

11. Successful Cardholders who are Winners:

- a. with a residential address in Peninsular Malaysia, may choose any one (1) of the available Campaign Gifts as set out in clause 9a above;
- b. without a residential address in Peninsular Malaysia, shall be entitled one (1) Campaign Gift as set out in clause 9b above,

following receipt of an email from CompareHero.my confirming their eligibility for gift redemption and will receive their chosen Campaign Gift (subject always to availability of third-party distribution and supply channels, stock availability and/or merchant delivery schedules, over which we have no control).

12. Successful Cardholders who are **not** Winners:

- a. with a residential address in Peninsular Malaysia, shall be entitled to receive one (1) “**Consolation Gift**”, Consolation Gift is defined as **one (1) unit of Condotti Nylon Laptop Backpack CL16 worth RM119 (recommended retail value)**;
- b. without a residential address in Peninsular Malaysia, will not be issued a Campaign Gift or Consolation Gift but will be issued one (1) “**Substitute Gift**” instead. Substitute Gift is defined as **one (1) RM50 Shopee eVoucher**.

13. Successful Cardholders who receive the Campaign Gift, Consolation Gift or the Substitute Gift, as applicable, shall not be eligible to participate in other sign-up card campaigns, promotions or offers by CIMB or its third-party sales agents.

### Campaign Gift Redemption

14. For the avoidance of doubt, it is the Successful Cardholder’s responsibility to redeem the Campaign Gift, Consolation Gift or Substitute Gift (as applicable) within the Redemption Period.

15. CompareHero.my will announce and contact the **40 Winners** after completing the determination of Winners between **20 December 2021 to 28 February 2022**:

- a. via email (email address in CompareHero.my’s record) with gift redemption instructions; and/or
- b. via SMS (mobile phone number in CompareHero.my’s record).

16. CompareHero.my will contact all Successful Cardholders to redeem the Consolation Gift or Substitute Gift, as applicable, between **20 December 2021 to 28 February 2022**:

- a. via email (email address in CompareHero.my’s record) with gift redemption instructions; and/or
- b. via SMS (mobile phone number in CompareHero.my’s record).

17. The Campaign Gift, Consolation Gift or Substitute Gift cannot be transferred to other parties, is not refundable and are strictly not exchangeable for cash, credit, or other goods.

18. The Campaign Gift, Consolation Gift or Substitute Gift is considered redeemed when a Successful Cardholder responds to the gift redemption email instructions before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no Campaign Gift, Consolation Gift or Substitute Gift will be issued.

19. Delivery or fulfilment of Campaign Gift, Consolation Gift or Substitute Gift is estimated to be four (4) weeks from redeemed date (subject always to availability of third-party distribution and supply channels, stock availability and/or merchant delivery schedules, over which we have no control). CompareHero.my is not responsible for any wrongful



or missing delivery of the Campaign Gift, Consolation Gift or Substitute Gift due to any incorrect or incomplete address supplied by the Successful Cardholder. No replacement of Campaign Gift and/or Substitute Gift will be offered.

20. The Campaign Gift, Consolation Gift or Substitute Gift choice of size, technical specifications and/or colour is at the discretion of CompareHero.my, based on available stock from the merchant/s. CompareHero.my can replace the Campaign Gift, Consolation Gift or Substitute Gift with something of equivalent or higher value if the merchant/s runs out of stock.
21. The Campaign Gift, Consolation Gift or Substitute Gift does not include any accessories or items (unless stated) that may be shown on any marketing materials, as they are for illustration purposes only.
22. The recommended retail value of the gifts provided above is for reference purposes only and is subject to change by the issuing merchant, over which CompareHero.my has no control.
23. The use of the Campaign Gift, Consolation Gift or Substitute Gift is subject to terms and conditions of the issuing merchant/s. All additional terms and conditions will be stated in full, upon delivery or fulfilment of Campaign Gift, Consolation Gift or Substitute Gift. Additional terms and conditions may include validity dates, spend requirements, applicable or exclusion products and other conditions. The issuing merchant/s reserves the right to alter, cancel, terminate, or suspend the order or any part thereof or any part of the applicable terms and conditions from time to time, with or without any prior notice.
24. All servicing or warranty claims should be directed to the merchant, manufacturer or distributor of the Campaign Gift, Consolation Gift or Substitute. Please refer to the warranty card / box / notification attached with the Campaign Gift, Consolation Gift or Substitute Gift.
25. CompareHero.my and CIMB are not in any way endorsing, sanctioning, approving or supporting the brand/s or merchandise of the Campaign Gift, Consolation Gift or Substitute Gift. Any query and/or dispute on the usage of the Campaign Gift, Consolation Gift or Substitute Gift must be directed to, and resolved directly with the issuing merchant/s.
26. Campaign Gift, Consolation Gift or Substitute Gift brand/s or merchandise are not a participant in or sponsor of this **CCFD2111CI-Campaign**. The brand/s logo and/or trademarks remains the intellectual property of the brand.
27. By accepting the Campaign Gift, Consolation Gift or Substitute Gift, the Successful Cardholder agrees to give CompareHero.my the discretion to publish their name and masked phone number in a list on all CompareHero.my's website, social media accounts and communication platforms.

### General Campaign Terms and Conditions

28. The use of the CompareHero.my website and services constitutes the acceptance of the general [Terms and Conditions](#) and [Privacy Policy](#).
  - a. For the avoidance of doubt, during the course of using CompareHero.my services, individuals that have registered their interest and/or have applied for a CIMB product listed on CompareHero.my, are deemed to have given explicit consent to the collection, use and sharing of their personal data between CompareHero.my and CIMB, for the purposes of the administration of this Campaign, including application status, card activation status, and other qualifying criteria.
29. CompareHero.my reserves the right to (at its own discretion) disqualify any participant and/or withhold or confiscate in full or part any Campaign Gift, Consolation Gift or Substitute Gift if:
  - a. the participant is found to be, or reasonably suspected of participating in any form of fraudulent practices (including but not limited to false identities, doctoring images, wilful spamming or manipulation of any CompareHero's processes, or website); and/or
  - b. the redemption request is found to have been made via other channels, made outside of the Redemption Period, or are fraudulent, against the spirit of the Campaign, or non-compliant with the Campaign Terms and Conditions

30. In the event of disputes, CompareHero.my's decision shall be final.
31. Where we suspect a participant is participating in any form of unlawful and/or fraudulent activity, we reserve the right to report such activity or suspicions to the police or relevant authorities.
32. Final approval of any Eligible Credit Card is determined by the relevant banks in their absolute discretion and is subject to the banks' credit and risk processing criteria. Participating in this Campaign does not guarantee the approval of any Credit Card. CompareHero.my does not guarantee the approval of any Eligible Credit Card.
33. CompareHero.my reserves the right as it deems fit to vary or change any of these campaign terms and conditions from time to time or cancel, terminate, withdraw, suspend and/or replace this Campaign with another similar Campaign with prior notice. Such variation, changes, cancellation, termination, withdrawal, suspension and/or replacement will be notified by posting on CompareHero.my website, social media or in any other manner as CompareHero.my deems fit.
34. CompareHero.my reserves the right to change the Sign-up Period or Redemption Period if the launch of the Campaign is delayed and shall have no liability for the same.
35. In this respect, the participants of this Campaign also signifies their agreement to access the CompareHero.my website and/or social media at regular intervals to view these terms and conditions and to ensure that they are kept up-to-date with any variations or changes which CompareHero.my may effect from time to time. Participants also agree that their continued participation in this Campaign will constitute their acceptance of these terms and conditions (as varied from time to time).
36. Any cancellation, termination, withdrawal or suspension by CompareHero.my of this Campaign will not entitle participants to any compensation against CompareHero.my for any and all loss or damage that may be suffered or incurred by the participant as a direct or indirect result of the act of cancellation, termination, withdrawal or suspension.
37. The decisions of CompareHero.my and CIMB in relation to every aspect of the Campaign, including but not limited to the definition of Successful Cardholders, shall be deemed final and conclusive under any circumstance and no further appeal, enquiry and/or correspondence will be entertained.
38. These Campaign terms and conditions are governed by and construed under the laws of Malaysia.
