

April 2020 Standard Chartered Credit Cards Standard Promotion Terms & Conditions

1. The April 2020 Standard Chartered Credit Cards Standard Promotion (hereinafter referred to as “**CCSP2004SC-Promotion**”) is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Standard Chartered Bank Malaysia Berhad (115793-P), (hereinafter referred to as “**Standard Chartered**”), as a Service Provider for bank products that are being applied for.
2. Standard Chartered credit cards eligible for CCSP2004SC-Promotion are the Standard Chartered Visa Platinum Card, Standard Chartered WorldMiles World Mastercard® and Standard Chartered JustOne Platinum Mastercard® (hereinafter referred to as “**Eligible Credit Cards**”).

Promotion Period

3. The CCSP2004SC -Promotion comprises of the following periods:
 - a. “**Sign-Up Period**” runs from 17 April 2020 to 31 May 2020, both dates inclusive; and
 - b. “**Redemption Period**” runs from 1 June 2020 to 16 September 2020, both dates inclusive.

Promotion Eligibility

4. The CCSP2004SC-Promotion is open to individuals who are:
 - a. 21 years old and above, with a residential address in Peninsular Malaysia; and
 - b. is either a New-to-Bank or New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Standard Chartered.
 - ii. New-to-Card is defined as existing bank customer who does not hold any active credit card/s from Standard Chartered.
 - c. successfully registers interest for any of the Eligible Credit Cards via CompareHero.my website (<https://www.comparehero.my>) or Facebook (<www.facebook.com/CompareHero.my>) or Instagram (<www.instagram.com/comparehero.my>) during the Sign-Up Period; and
 - d. have their application of the Eligible Credit Cards approved and activated (hereinafter referred to as “**Cardholder/s**”) within thirty (30) days from the end date of CCSP2004SC-Promotion.
5. The following individuals are not eligible for the CCSP2004SC-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCSP2004SC-Promotion; and/or
 - b. existing Standard Chartered cardholders who cancel any of the Eligible Credit Cards within six (6) months from the date of approval of their Eligible Credit Cards’ application; and/or
 - c. existing Standard Chartered cardholders who are participating in any other concurrent Standard Chartered credit card promotions; and/or
 - d. holder(s) of invalid or cancelled Standard Chartered Eligible Credit Cards and/or whose accounts are delinquent within Standard Chartered’s definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate Standard Chartered credit cards; and/or
 - f. those who make a direct or online application for any of Eligible Credit Cards at any Standard Chartered branch / Standard Chartered websites / Standard Chartered sales representatives / other third-party sales agents.
6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5, and its subclauses) will be considered a “**Successful Cardholder**” of the CCSP2004SC-Promotion.
8. Each Successful Cardholder is entitled to only one (1) CCSP2004SC-Promotion gift (hereinafter referred to as “**Promotion Gift**”), regardless of the number of approved and activated Eligible Credit Cards from Standard Chartered.
9. Promotion Gift is defined as a single unit (1 unit) of Aicook 7 in 1 Programmable Pressure Cooker with Non-Stick Inner Pot 6.0L Rice Cooker Multi Cooker.

Gift Redemption

For the avoidance of doubt, it is the Successful Cardholder's responsibility to redeem the Promotion Gift within the Redemption Period.

10. CompareHero.my will contact all Successful Cardholders to redeem the Promotion Gift, between 4-8 weeks after card activation (pending official Standard Chartered reports):
 - a. via email (email address in CompareHero.my's record) with gift redemption instructions; and/or
 - b. via SMS (mobile phone number in CompareHero.my's record).
11. At the time of gift redemption, should a Successful Cardholder be unable to provide a residential address in Peninsular Malaysia or declines the said Promotion Gift, a "**Substitute Gift**" will be issued.
 - a. Substitute Gift is defined as a RM200 Lazada eVoucher and request for other options will not be entertained.
12. Promotion Gift or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
13. Promotion Gift or Substitute Gift is considered redeemed when a Successful Cardholder responds to the gift redemption email instructions before the end of the Redemption Period. The issuing merchant/s reserves the right to alter, cancel, terminate or suspend the order or any part thereof or any part of the applicable terms and conditions from time to time, with or without any prior notice.
