September 2023 CompareHero Car Insurance Hero Giveaway Campaign Terms & Conditions

- The September 2023 CompareHero Car Insurance Hero Giveaway Campaign (hereinafter referred to as "CIHG2309CH1-Campaign") is organized by Compargo Malaysia Sdn Bhd [201301020939 (1050769-U)] for CompareHero (hereinafter referred to as "CompareHero" or "we") and in partnership with Allianz General Insurance Company (Malaysia) Berhad [200601015674 (735426-V)] (hereinafter referred to as "Allianz") and Zurich General Takaful Malaysia Berhad [(201701045981 (1260157-U)] (hereinafter referred to as "Zurich") as a Service Provider for Car Insurance products that are being applied for.
- 2. The eligible products for **CIHG2309CH1-Campaign** are Allianz Motor Comprehensive Cover and Zurich Comprehensive Motor Takaful (hereinafter referred to as "**Eligible Car Insurance(s)**").

Campaign Period

- 3. The CIHG2309CH1- Campaign comprises of the following periods:
 - a. "Purchase Period" runs from 27 September 2023 to 31 October 2023, both dates inclusive;
 - b. "Redemption Message" is the communication sent to each Successful Policy Holder (defined below) by CompareHero containing gift redemption status.

Campaign Eligibility

- 4. The CIHG2309CH1- Campaign is open to individuals who:
 - a. Have a residential address in Malaysia; and
 - b. Successfully purchase an Eligible Car Insurance policy from the Insurance Providers through CompareHero; and
 - c. have their application for the Eligible Car Insurance(s) policy <u>successfully issued by Allianz and Zurich</u> (hereinafter referred to as "**Successful Policy Holders**") and the policy gross premium (excluding Stamp Duty and Service Tax) payable for such Eligible Car Insurance policy is **at least RM 500 and above**.

- 5. The following individuals are <u>not eligible</u> for the **CIHG2309CH1- Campaign**:
 - a. permanent and/or contract employees of Allianz and Zurich (including its subsidiaries and related companies) and their respective immediate family members; and/or
 - b. representatives and/or agents (including advertising and campaign agents) of Allianz and Zurich and their respective immediate family members; and/or
 - c. any person who has committed or suspected of committing any misconduct, fraudulent or wrongful acts in relation to their personal financing account(s), any facility, service or accommodation granted by Allianz and Zurich, including Allianz and Zurich Online (Website); and/or
- 6. CompareHero reserves the right to reject information submitted on the CompareHero website and/or social media if we deem it not legible, in non-English alphabets, to use foul language, or suspect it as spam or of a fraudulent nature.

7. Campaign Mechanics

- 8. Policy Holders who fulfil the Campaign Eligibility requirements set out in clauses 4 and 5, and their subclauses set out in campaign eligibility will be considered a "Successful Policy Holders" of the CIHG2309CH1-Campaign.
- 9. Each **Successful Policy Holder** entitled to and shall only receive one (1) Campaign Gift regardless of the number of policies purchased via CompareHero with the Participating Insurance company (hereinafter referred to "**Allianz**" and "**Zurich**").

- 10. A "Campaign Gift" is defined as one (1) unit of Shell Petrol Vouchers worth RM30.

With notification that the Campaign Gift has been credited to the Successful Policy Holder's Touch 'n Go e-Wallet account (a "Redemption Message"), as applicable.

- 14. The Campaign Gift cannot be transferred to other parties, is not refundable and are strictly not exchangeable for cash, credit, or other goods.
- 15. The Campaign Gift is considered <u>redeemed</u> when a Successful Policy Holders responds to the Redemption Message before the end of the Redemption Period. Any attempt of gift redemption after the Redemption Period will not be entertained and no Campaign Gift will be issued.

Any query and/or dispute on the usage of the Campaign Gift must be directed to, and resolved directly with the issuing merchant/s.
- 21. Campaign Gift brand/s or merchandise are not a participant in or sponsor of this **CIHG2309CH1-Campaign**. The brand/s logo and/or trademarks remains the intellectual property of the brand.
- 22. In order to receive Campaign Gift for the **CIHG2309CH1-Campaign**, Successful Policy Holders must have already registered an account to receive credit with <u>Touch 'n Go</u> in accordance with the following conditions:
 - a. Successful Policy Holders must verify their <u>Touch 'n Go</u> account (the "**Touch 'n Go ID**") by linking their mobile number ("**Mobile Number**") with their Touch 'n Go account in order for the Campaign Gift to be transferred.
 - In order for the Successful Policy Holders to be eligible to receive the Campaign Gift, the Mobile Number must match the details supplied by the Successful Policy Holders when applying for the CIHG2309CH1-Campaign on CompareHero. If and the Mobile Number is the same, then no further action is required.
 - c. For the avoidance of doubt, Campaign Gift will not be transferrable to a Touch 'n Go ID that does not meet each of the foregoing conditions.

- 25. CompareHero reserves the right to (at its own discretion) disqualify any participant and/or withhold or confiscate in full or part any Campaign Gift if:
 - a. the participant is found to be, or reasonably suspected of participating in any form of fraudulent practices (including but not limited to false identities, doctoring images, wilful spamming or manipulation of any CompareHero's processes, or website); and/or
 - b. the redemption request is found to have been made via other channels, made outside of the Redemption Period, or are fraudulent, against the spirit of the Campaign, or non-compliant with the Campaign Terms and Conditions.
- 26. In the event of disputes, CompareHero's decision shall be final.
- 27. Where we suspect a participant is participating in any form of unlawful and/or fraudulent activity, we reserve the right to report such activity or suspicions to the police or relevant authorities.
- 28. Final approval of any Eligible Car Insurance is determined by Participating Insurance company and is subject to the Insurance company's internal policies. Participating in this Campaign does not guarantee the Issuances of any Car Insurance. CompareHero does not guarantee the Issuances of any Eligible Car Insurance.
- 29. CompareHero reserves the right as it deems fit to vary or change any of these Campaign terms and conditions from time to time or cancel, terminate, withdraw, suspend and/or replace this Campaign with another similar Campaign with prior notice. Such variation, changes, cancellation, termination, withdrawal, suspension and/or replacement will be notified by posting on CompareHero website, social media or in any other manner as CompareHero deems fit.
- 30. CompareHero reserves the right to change the Purchase Period or Redemption Message if the launch of the Campaign is delayed and shall have no liability for the same.
- 31. In this respect, the participants of this Campaign also signifies their agreement to access the CompareHero website and/or social media at regular intervals to view these terms and conditions and to ensure that they are kept up-to-date with any variations or changes which CompareHero may effect from time to time. Participants also agree that their continued participation in this Campaign will constitute their acceptance of these terms and conditions (as varied from time to time).
