



April 2020 Standard Chartered Credit Cards Hero Giveaway Promotion Terms & Conditions

- This Standard Chartered Credit Cards Hero Giveaway Promotion (hereinafter referred to as "CCHG2004SC-Promotion") is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with Standard Chartered Bank Malaysia Berhad (115793-P) (hereinafter referred to as "Standard Chartered").
- Standard Chartered credit cards eligible for CCHG2004SC-Promotion are Standard Chartered WorldMiles World
 Mastercard®, Standard Chartered Visa Platinum Card, and Standard Chartered JustOne Platinum Mastercard®
 (hereinafter referred to as "Eligible Credit Cards").

Promotion Period

- 3. The CCHG2004SC-Promotion comprises of the following periods:
 - a. "Sign-Up Period" runs from 6 April 2020 to 8 April 2020, both dates inclusive; and
 - b. "Redemption Period" runs from 15 May 2020 to 31 July 2020, both dates inclusive.

Promotion Eligibility

- 4. The CCHG2004SC-Promotion is open to individuals who are:
 - a. 21 years old and above, with a residential address in Peninsular Malaysia; and
 - b. successfully <u>registers interest</u> for any of the Eligible Credit Cards via CompareHero.my website (https://www.comparehero.my) or Facebook (www.facebook.com/CompareHero.my) or Instagram (www.instagram.com/comparehero.my) during the Sign-Up Period; and
 - c. is either a New-to-Bank or New-to-Card applicant; and
 - i. New-to-Bank is defined as a person who does not have any accounts or a financial relationship with Standard Chartered.
 - ii. New-to-Card is defined as an existing bank customer who does not hold any active credit card/s from Standard Chartered in the past six (6) months.
 - d. have their application of the Eligible Credit Cards <u>approved and activated</u> (hereinafter referred to as "Cardholder/s") within thirty (30) days from the end date of CCHG2004SC-Promotion.
- 5. The following individuals are <u>not eligible</u> for the CCHG2004SC-Promotion:
 - a. those who have registered under a different CompareHero.my promotion within three (3) months from the start date of CCHG2004SC-Promotion; and/or
 - b. existing Standard Chartered cardholders who cancel any of the Eligible Credit Cards within six (6) months from the date of approval of their Eligible Credit Cards' application; and/or
 - c. existing Standard Chartered cardholders who are participating in any other concurrent Standard Chartered credit card promotions; and/or
 - d. holder(s) of invalid or cancelled Standard Chartered Eligible Credit Cards and/or whose accounts are delinquent within Standard Chartered's definition at any time during the Sign-Up Period; and/or
 - e. holder(s) of a company and/or corporate Standard Chartered credit cards; and/or
 - f. those who make a direct or online application for any of Eligible Credit Cards at any Standard Chartered branch / Standard Chartered websites / Standard Chartered sales representatives / other third-party sales agents.
- 6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

Promotion Mechanics

- 7. Cardholders who fulfil Promotion Eligibility (clauses 4 and 5, and its subclauses) will be considered a "Successful Cardholder" of the CCHG2004SC-Promotion.
- 8. Each Successful Cardholder is entitled to only one (1) CCHG2004SC-Promotion gift (hereinafter referred to as "**Promotion Gift**"), regardless of the number of approved and activated Eligible Credit Cards from Standard Chartered.
 - a. Each Successful Cardholder has to **choose only ONE (1) of two available Promotion Gift(s)** when they sign up for a credit card.
 - b. Promotion Gift decision by Successful Cardholders is final and no further changes will be entertained.





- c. CompareHero reserves the right to change or replace the gift based on the available stock from the merchants. Refer to Clause 15.
- 9. Promotion Gift is defined as one (1) Samsung 24 Inch Curved FHD Monitor OR one (1) Tefal Fry Delight Air Fryer.

Gift Redemption

- 10. For the avoidance of doubt, at the time of gift redemption, should a Successful Cardholder be unable to provide a residential address in Peninsular Malaysia or declines the said Promotion Gift, a "**Substitute Gift**" will be issued.
 - a. Substitute Gift is defined as an RM200 Lazada eVoucher and request for other options will not be entertained.
- 11. Promotion Gift or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
- 12. CompareHero.my will contact all Successful Cardholders between 4-8 weeks after card activation date (pending official Standard Chartered reports):
 - a. via email (email address in CompareHero.my's record) with gift redemption instructions; and/or
 - b. <u>via SMS</u> (mobile phone number in CompareHero.my's record)
- 13. Promotion Gift or Substitute Gift is considered <u>redeemed</u> when a Successful Cardholder responds to the gift redemption email instructions <u>before the end of the Redemption Period</u>. Any attempt of gift redemption after the Redemption Period will not be entertained and no Promotion Gift will be issued.
