



## **April 2020 HSBC Credit Cards Standard Promotion Terms & Conditions**

- The April 2020 HSBC Credit Cards Standard Promotion (hereinafter referred to as "CCSP2004HS-Promotion") is organized by Compargo Malaysia Sdn Bhd (1050769-U) for CompareHero.my and in partnership with HSBC Bank Malaysia Berhad (127776-V) and HSBC Amanah Malaysia Berhad (807705-X), (hereinafter referred to as "HSBC") as a Service Provider for bank products that are being applied for.
- 2. HSBC credit cards eligible for CCSP2004HS-Promotion are HSBC Amanah MPower Visa Platinum Credit Card-i, HSBC Platinum and HSBC Visa Signature (hereinafter referred to as "Eligible Credit Cards").

#### **Promotion Period**

- 3. The CCSP2004HS-Promotion comprises of the following periods:
  - a. "Sign-Up Period" runs from 15 April 2020 to 31 May 2020, both dates inclusive;
  - b. "Spend Period" defined as 60 days from the date of the HSBC credit card welcome letter; and
  - c. "Redemption Period" runs from 1 June 2020 to 15 Sept 2020, both dates inclusive;

## **Promotion Eligibility**

- 4. The CCSP2004HS-Promotion is open to individuals who are:
  - a. 21 years old and above; and
  - b. Having a residential address in Peninsular Malaysia; and
  - c. is either a New-to-Bank or New-to-Card applicant; and
    - New-to-Bank is defined as a person who does not have any accounts or a financial relationship with HSBC.
    - New-to-Card is defined as an existing bank customer who does not hold any active credit card/s from HSBC.
  - d. must <u>register interest</u>, during the Sign-Up Period, for any of the Eligible Credit Cards on CompareHero.my website, to get <u>redirected</u> to HSBC website; and
  - e. completes the HSBC online application process before the end of the Sign-Up Period; and
  - f. have their application of the Eligible Credit Cards <u>approved and activated</u> (hereinafter referred to as "Cardholder/s") within forty-five (45) days from the end date of the promotion.
- 5. The following individuals are <u>not eligible</u> for the CCSP2004HS-Promotion:
  - a. permanent and/or contract employees of HSBC\_(including its subsidiaries and related companies) and their respective immediate family members; and/or
  - b. representatives and/or agents (including advertising and campaign agents) of HSBC and their respective immediate family members; and/or
  - c. any individuals who had cancelled any of his/her HSBC credit card within six (6) months before the date of application and is re-applying for any HSBC Credit Card under the CCSP2004HS-Promotion; and/or
  - d. present holders of any HSBC credit card(s) whether issued in Malaysia or otherwise; and/or
  - e. any person who has committed or suspected of committing any misconduct, fraudulent or wrongful acts in relation to their card account(s), any facility, service or accommodation granted by HSBC, including HSBC Online (Website); and/or
  - f. those who apply for any of the Eligible Credit Cards via other methods from Clause 4(c) and 4(d).
- 6. CompareHero.my reserves the right to reject information submitted on the CompareHero.my website and social media if we deem it not legible, in non-English alphabets, use of foul language, or suspected as spam.

#### **Promotion Mechanics**

- 7. Cardholders who perform a "Minimum Spend" of RM1,000.00 (or equivalent in foreign currency) on "Eligible Spend" in a single or cumulative receipt(s) within the Spend Period will be considered a "Successful Cardholder".
  - a. **Eligible Spend** of the CCSP2004HS-Promotion are spend charged to the Eligible Credit Cards, subject to the conditions below:
    - i. includes: internet transactions, local and overseas retail transactions (including online transactions), standing instructions/auto-billing;
    - ii. excludes: Cash advance, Balance Transfer (BT), Cash Instalment Plan (CIP), Interest charges, finance charges/management fees, credit card annual fees, and the Goods and Services Tax on annual fees, E-wallet top up/quasi cash transactions, for the Eligible Credit Cards.





- 8. Each Successful Cardholder is entitled to only one (1) CCSP2004HS-Promotion gift (hereinafter referred to as "Promotion Gift"), regardless of the number of approved and activated Eligible Credit Cards from HSBC.
- 9. Promotion Gift is defined as a single unit (1) of Khind Bread Maker BM750.
- 10. Successful Cardholders who receive the Promotion Gift are not able to participate in other sign-up card campaigns, promotions or offers by HSBC or its third-party sales agents.
- 11. Successful Cardholders without a residential address in Peninsular Malaysia will be issued a "Substitute Gift" instead.
  - a. Substitute Gift is defined as a **RM200 Lazada eVoucher** and request for other options will not be entertained.

### **Promotion Gift Redemption**

- 12. For the avoidance of doubt, it is the Successful Cardholder's responsibility to redeem the Promotion Gift or Substitute within their respective Redemption Periods.
- 13. CompareHero.my will contact all Successful Cardholders to redeem the Promotion Gift or Substitute Gift, between 4-8 weeks after card activation (pending official HSBC reports):
  - a. via email (email address in CompareHero.my's record) with gift redemption instructions; and/or
  - b. via SMS (mobile phone number in CompareHero.my's record).
- 14. The Promotion Gift or Substitute Gift cannot be transferred to other parties, is not refundable and not exchangeable for cash, credit, or other goods.
- 15. The Promotion Gift or Substitute Gift is considered <u>redeemed</u> when a Successful Cardholder responds to the gift redemption email instructions <u>before the end of the Redemption Period</u>. Any attempt of gift redemption after the Redemption Period will not be entertained and no Promotion Gift will be issued.
- 16. Delivery or fulfilment of Promotion Gift or Substitute Gift is estimated to be 4 weeks from redeemed date (pending stock availability, and/or merchant delivery schedules).
- 17. The Promotion Gift or Substitute Gift choice of size, technical specifications and/or colour is at the discretion of CompareHero.my, based on available stock from the merchant/s. CompareHero.my can replace the Promotion Gift or Substitute Gift with something of equivalent or higher value if the merchant/s runs out of stock.
- 18. The Promotion Gift or Substitute Gift does not include any accessories or items (unless stated) that may be shown on any marketing materials, as they are for illustration purposes only.
- 19. The use of the Promotion Gift or Substitute Gift is subject to terms and conditions of the issuing merchant/s. All additional terms and conditions will be stated in full, upon delivery or fulfilment of Promotion Gift. Additional terms and conditions may include validity dates, spend requirements, applicable or exclusion products and other conditions. The issuing merchant/s reserves the right to alter, cancel, terminate or suspend the order or any part thereof or any part of the applicable terms and conditions from time to time, with or without any prior notice.
- 20. All servicing or warranty claims should be directed to the merchant, manufacturer or distributor of the Promotion Gift or Substitute Gift. Please refer to the warranty card / box / notification attached with the Promotion Gift.
